- 8 (II) A CURE OF THE DEFAULT DOES NOT RELIEVE THE
- 9 OFFENDING STATE OF OBLIGATIONS OR LIABILITIES INCURRED DURING THE

- 11 (3) (I) TERMINATION OF MEMBERSHIP IN THIS COMPACT SHALL
- 12 BE IMPOSED ONLY AFTER ALL OTHER MEANS OF SECURING COMPLIANCE HAVE
- 13 BEEN EXHAUSTED.
- 14 (II) NOTICE OF INTENT TO SUSPEND OR TERMINATE SHALL BE
- 15 GIVEN BY THE COMMISSION TO THE GOVERNOR OF THE DEFAULTING STATE, TO THE
- 16 EXECUTIVE OFFICER OF THE DEFAULTING STATE'S LICENSING BOARD, THE
- 17 DEFAULTING STATE'S LICENSING BOARD, AND TO EACH OF THE PARTY STATES.

- 27 (6) (I) THE DEFAULTING STATE MAY APPEAL THE ACTION OF THE
- 28 COMMISSION BY PETITIONING THE U.S. DISTRICT COURT FOR THE DISTRICT OF
- 29 COLUMBIA OR THE FEDERAL DISTRICT IN WHICH THE COMMISSION HAS ITS
- 30 PRINCIPAL OFFICES.
- 31 (II) THE PREVAILING PARTY SHALL BE AWARDED ALL COSTS OF
- 32 SUCH LITIGATION, INCLUDING REASONABLE ATTORNEY'S FEES.

- 1 (C) (1) ON REQUEST BY A PARTY STATE, THE COMMISSION SHALL 2 ATTEMPT TO RESOLVE DISPUTES RELATED TO THE COMPACT THAT ARISE AMONG 3 PARTY STATES AND BETWEEN PARTY AND NONPARTY STATES.

- 15 (D) (1) THE COMMISSION, IN THE REASONABLE EXERCISE OF ITS 16 DISCRETION, SHALL ENFORCE THE PROVISIONS AND RULES OF THIS COMPACT.
- 17 (2) (I) BY MAJORITY VOTE, THE COMMISSION MAY INITIATE LEGAL
- 18 ACTION IN THE U.S. DISTRICT COURT FOR THE DISTRICT OF COLUMBIA OR THE
- 19 FEDERAL DISTRICT IN WHICH THE COMMISSION HAS ITS PRINCIPAL OFFICES
- 20 AGAINST A PARTY STATE THAT IS IN DEFAULT TO ENFORCE COMPLIANCE WITH THE

- 22 (II) THE RELIEF SOUGHT MAY INCLUDE BOTH INJUNCTIVE 23 RELIEF AND DAMAGES.
- 24 (III) IN THE EVENT JUDICIAL ENFORCEMENT IS NECESSARY, THE
- 25 PREVAILING PARTY SHALL BE AWARDED ALL COSTS OF SUCH LITIGATION,
- 26 INCLUDING REASONABLE ATTORNEY'S FEES.
- 27 (3) (I) THE REMEDIES PROVIDED FOR IN THIS ARTICLE MAY NOT 28 BE THE EXCLUSIVE REMEDIES OF THE COMMISSION.

- 1 (A) THIS COMPACT SHALL COME INTO LIMITED EFFECT AT SUCH TIME AS

 12 MONTHS AFTER ENACTMENT OF THE REPEALING STATUTE.
- 13 (D) A PARTY STATE'S WITHDRAWAL OR TERMINATION MAY NOT AFFECT THE
- 14 CONTINUING REQUIREMENT OF THE WITHDRAWING OR TERMINATED STATE'S
- 15 LICENSING BOARD TO REPORT ADVERSE ACTIONS AND SIGNIFICANT
- 16 INVESTIGATIONS OCCURRING BEFORE THE EFFECTIVE DATE OF THE WITHDRAWAL
- 17 OR TERMINATION.
- 18 (E) NOTHING CONTAINED IN THIS COMPACT SHALL BE CONSTRUED TO
- 19 INVALIDATE OR PREVENT ANY APRN LICENSURE AGREEMENT OR OTHER
- 20 COOPERATIVE ARRANGEMENT BETWEEN A PARTY STATE AND A NONPARTY STATE
- 21 THAT IS MADE IN ACCORDANCE WITH THE PROVISIONS OF THIS COMPACT.
- 22 (F) (1) THIS COMPACT MAY BE AMENDED BY THE PARTY STATES.
- 23 (2) AN AMENDMENT TO THIS COMPACT MAY NOT BECOME EFFECTIVE
- 24 AND BINDING ON THE PARTY STATES UNLESS AND UNTIL IT IS ENACTED INTO THE
- 25 LAWS OF ALL PARTY STATES.
- 26 (G) REPRESENTATIVES OF NONPARTY STATES TO THIS COMPACT SHALL BE
- 27 INVITED TO PARTICIPATE IN THE ACTIVITIES OF THE COMMISSION, ON A
- 28 NONVOTING BASIS, BEFORE THE ADOPTION OF THIS COMPACT BY ALL STATES.

- 30 (A) THIS COMPACT SHALL BE LIBERALLY CONSTRUED SO AS TO 31 EFFECTUATE THE PURPOSES OF THE COMPACT.

THE PROVISIONS OF THIS COMPACT SHALL BE SEVERABLE, AND IF ANY 1 (B) 2 PHRASE, CLAUSE, SENTENCE, OR PROVISION OF THIS COMPACT IS DECLARED TO BE 3 CONTRARY TO THE CONSTITUTION OF ANY PARTY STATE OR OF THE UNITED 4 STATES, OR IF THE APPLICABILITY THEREOF TO ANY GOVERNMENT, AGENCY, PERSON, OR CIRCUMSTANCE IS HELD INVALID, THE VALIDITY OF THE REMAINDER 5 6 OF THIS COMPACT AND THE APPLICABILITY THEREOF TO ANY GOVERNMENT, 7 AGENCY, PERSON, OR CIRCUMSTANCE SHALL NOT BE AFFECTED THEREBY. 8 IF THIS COMPACT IS HELD TO BE CONTRARY TO THE CONSTITUTION OF 9 A PARTY STATE, THIS COMPACT SHALL REMAIN IN FULL FORCE AND EFFECT AS TO THE REMAINING PARTY STATES AND IN FULL FORCE AND EFFECT AS TO THE PARTY 10 STATE AFFECTED AS TO ALL SEVERABLE MATTERS. 11 12 SECTION 2. AND BE IT FURTHER ENACTED, That on the formation of the Interstate Commission of APRN Compact Administrators established under Section 1 of 13 14 this Act, the Compact Administrator of the State shall recommend that: 15 an APRN Advisory Committee be formed and composed of advanced (1) 16 practice registered nurses seated on party state licensing boards; and 17 the APRN Advisory Committee advise the Interstate Commission of Compact Administrators of regulatory matters, as needed. 18 19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act is contingent on the 20 enacting of substantially similar legislation in six other states. The Maryland Department 21of Health shall notify the Department of Legislative Services within 10 days after any state 22has enacted legislation that is substantially similar to this Act. 23 SECTION 4.
