A BILL ENTITLED

1 AN ACT concerning

2 **Department of Human Services – Children in Foster Care – Luggage**

3 FOR the purpose of requiring the Department of Human Services to establish and maintain
4 a decentralized supply of new luggage to be used to transport the personal belongings
5 of a child in foster care; requiring the Department to provide new luggage to a child
6 who is being removed from a household under certain circumstances; requiring the
7 Department to maintain certain records regarding luggage and children in foster
8 care; and generally relating to the Department of Human Services and children in
9 foster care.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Family Law**

18 **5–505.2.**

19 **(A) (1) IN THIS SECTION, “NEW LUGGAGE” MEANS A SUITCASE, DUFFEL**
20 **BAG, BACKPACK, OR SIMILAR CONTAINER THAT:**

21 **(I) IS DESIGNED TO HOLD AN INDIVIDUAL’S PERSONAL**
22 **BELONGINGS; AND**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (II) HAS NOT BEEN PREVIOUSLY USED.

2 (2) "NEW LUGGAGE" DOES NOT INCLUDE A DISPOSABLE BAG.

3 (B) THE DEPARTMENT SHALL:

4 (1) ESTABLISH AND MAINTAIN A DECENTRALIZED SUPPLY OF NEW
5 LUGGAGE TO BE USED TO TRANSPORT THE PERSONAL BELONGINGS OF A CHILD IN
6 FOSTER CARE; AND

7 (2) DEVELOP PROCEDURES FOR THE STORAGE AND DISTRIBUTION OF
8 NEW LUGGAGE INTENDED FOR CHILDREN IN FOSTER CARE.

9 (C) (1) SUBJECT TO PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, THE
10 DEPARTMENT SHALL PROVIDE NEW LUGGAGE TO A CHILD IN FOSTER CARE WHO IS
11 BEING REMOVED FROM A HOUSEHOLD.

12 (2) NEW LUGGAGE PROVIDED TO A CHILD UNDER THIS SUBSECTION:

13 (I) IS THE PROPERTY OF THE CHILD; AND

14 (II) MAY NOT BE RECLAIMED BY THE DEPARTMENT OR
15 RETAINED BY THE CHILD'S FOSTER PARENT.

16 (3) THE DEPARTMENT IS NOT REQUIRED TO PROVIDE ADDITIONAL
17 NEW LUGGAGE UNDER THIS SUBSECTION TO A CHILD WHO:

18 (I) IS CHANGING PLACEMENT; AND

19 (II) IS IN POSSESSION OF NEW LUGGAGE PREVIOUSLY
20 PROVIDED BY THE DEPARTMENT.

21 (D) (1) THE DEPARTMENT SHALL MAINTAIN A RECORD OF EACH
22 INSTANCE IN WHICH A DISPOSABLE BAG IS USED TO MOVE THE PERSONAL
23 BELONGINGS OF A CHILD IN FOSTER CARE.

24 (2) THE RECORD REQUIRED UNDER PARAGRAPH (1) OF THIS
25 SUBSECTION SHALL INCLUDE THE REASON THE DEPARTMENT DID NOT PROVIDE
26 THE CHILD WITH NEW LUGGAGE TO MOVE THE CHILD'S PERSONAL BELONGINGS.

27 (E) THE DEPARTMENT MAY SOLICIT AND ACCEPT GIFTS, GRANTS, AND
28 DONATIONS OF ANY KIND AND FROM ANY SOURCE TO CARRY OUT THE PROVISIONS
29 OF THIS SECTION.

1 **(F) ON OR BEFORE DECEMBER 1 EACH YEAR, THE DEPARTMENT SHALL**
2 **REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE**
3 **STATE GOVERNMENT ARTICLE, THE FOLLOWING INFORMATION:**

4 **(1) THE NUMBER OF INSTANCES IN WHICH A DISPOSABLE BAG WAS**
5 **USED TO TRANSPORT THE PERSONAL BELONGINGS OF A CHILD IN FOSTER CARE AND**
6 **THE REASON THE DEPARTMENT FAILED TO PROVIDE THE CHILD IN FOSTER CARE**
7 **WITH NEW LUGGAGE; AND**

8 **(2) THE DEPARTMENT'S SUPPLY INVENTORY AND INVENTORY**
9 **MANAGEMENT PROCEDURES FOR THE NEW LUGGAGE SUPPLY MAINTAINED UNDER**
10 **SUBSECTION (B) OF THIS SECTION.**

11 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**
12 **October 1, 2024.**
