

13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
15	Article – Education
16	18–1501.
17	(a) In this subtitle the following words have the meanings indicated.
18 19 20	(b) (1) "Eligible field of employment" means employment in the State by an organization, institution, association, society, or corporation that is exempt from taxation under § 501(c)(3) or (4) of the Internal Revenue Code of 1986.
21 22 23	(2) "Eligible field of employment" includes employment by the State or any local government in the State, but does not include being employed as a judicial clerk in any court.

Receives a graduate, professional, or undergraduate degree from:

11 12 13	(4) A limit on the total amount of assistance provided by the Office of Student Financial Assistance in repaying the loan of an eligible individual, based on the individual's total income and outstanding higher education loan balance;
14 15 16	(5) A procedure and schedule for the monthly or annual payment of the amount of loan assistance provided by the Office of Student Financial Assistance to the eligible individual, as appropriate to assist an eligible individual in meeting loan forgiveness program requirements;
18	(6) A requirement that an eligible individual apply to federal loan forgiveness programs for which the individual may qualify;
20 21	(7) A requirement that an eligible individual notify the Office of Student Financial Assistance if the individual receives other loan repayment assistance; and
22 23	(8) An annual review of the eligibility of each individual participating in the Program.
24 25	(b) The Office of Student Financial Assistance shall adopt any other regulations necessary to implement this subtitle.

- 1 (4) TO ELIGIBLE PUBLIC SCHOOL NURSES IN AN EFFORT TO RECRUIT 2 AND RETAIN NURSES WORKING IN PUBLIC SCHOOLS IN THE STATE.
