### CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Education – Public Libraries – Collective Bargaining**  
3 **(Library Workers Empowerment Act)**

4 FOR the purpose of authorizing employees of certain public libraries to form, join, and  
5 participate in an employee organization and engage in certain other activities related  
6 to collective bargaining; requiring certain employers and certified exclusive  
7 representatives to engage in good faith bargaining; establishing a collective  
8 bargaining process for employees of certain public libraries; establishing a process  
9 for resolving impasses during collective bargaining; prohibiting employers and  
10 employee organizations from engaging in certain actions regarding the exercise of an  
11 employee’s rights under this Act; prohibiting employers, employees, and employee  
12 organizations from engaging in certain actions related to strikes, work stoppages,  
13 boycotts, and lockouts; repealing certain provisions of law rendered obsolete by

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That Section(s) 23–601 through 23–614 and the subtitle “Subtitle 6. Howard County  
17 Library System – Collective Bargaining” of Article – Education of the Annotated Code of  
18 Maryland be repealed.

19 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
20 as follows:

22 **SUBTITLE 9. PUBLIC LIBRARIES – COLLECTIVE BARGAINING.**

24 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
25 INDICATED.

26 (B) (1) “CERTIFIED EXCLUSIVE REPRESENTATIVE” MEANS THE  
27 EMPLOYEE ORGANIZATION THAT HAS BEEN CERTIFIED AS THE COLLECTIVE  
28 BARGAINING AGENT FOR A BARGAINING UNIT.

29 (2) “CERTIFIED EXCLUSIVE REPRESENTATIVE” INCLUDES AN  
30 EMPLOYEE ORGANIZATION CERTIFIED TO EXCLUSIVELY REPRESENT PUBLIC  
31 LIBRARY EMPLOYEES BEFORE JULY 1, 2024.

32 (C) “CONFIDENTIAL EMPLOYEE” MEANS AN EMPLOYEE WHO:

33 (1) IS REQUIRED TO DEVELOP OR PRESENT MANAGEMENT POSITIONS  
34 WITH RESPECT TO EMPLOYER–EMPLOYEE RELATIONS; AND

1           (2) WHOSE DUTIES NORMALLY REQUIRE ACCESS TO CONFIDENTIAL  
2 INFORMATION THAT CONTRIBUTES SIGNIFICANTLY TO THE DEVELOPMENT OF THE  
3 MANAGEMENT POSITIONS WITH RESPECT TO EMPLOYER-EMPLOYEE RELATIONS.

4           (D) "DIRECTOR" MEANS THE DIRECTOR, CHIEF EXECUTIVE OFFICER, OR  
5 CHIEF OFFICER OF THE APPLICABLE PUBLIC LIBRARY SYSTEM, OR THE DESIGNEE  
6 OF THE DIRECTOR, CHIEF EXECUTIVE OFFICER, OR CHIEF OFFICER.

7           (E) (1) "EMPLOYEE" MEANS A FULL-TIME OR PART-TIME EMPLOYEE OF  
8 A PUBLIC LIBRARY SYSTEM.

9           (2) "EMPLOYEE" DOES NOT INCLUDE A CONFIDENTIAL EMPLOYEE,  
10 MANAGEMENT EMPLOYEE, OR SUPERVISORY EMPLOYEE.

11           (F) "EMPLOYEE ORGANIZATION" MEANS AN ORGANIZATION THAT ADMITS  
12 EMPLOYEES OF THE EMPLOYER AS MEMBERS AND HAS AS A PRIMARY PURPOSE THE  
13 REPRESENTATION OF THE EMPLOYEES IN THEIR RELATIONS WITH THE EMPLOYER.

14           (G) "EMPLOYER" MEANS A PUBLIC LIBRARY SYSTEM AND, WHERE  
15 APPLICABLE, THE BOARD OF TRUSTEES FOR THE PUBLIC LIBRARY SYSTEM.

16           (H) "~~GOVERNING~~ FUNDING BODY" MEANS:

17           (1) (I) FOR A CHARTER COUNTY THAT DOES NOT HAVE AN  
18 ELECTED CHIEF EXECUTIVE OFFICER, THE COUNTY COUNCIL; ~~OR~~

19                           (II) FOR A CHARTER COUNTY THAT HAS AN ELECTED CHIEF  
20 EXECUTIVE OFFICER, ~~THE COUNTY COUNCIL OR THE COUNTY COUNCIL AND THE~~  
21 ~~COUNTY EXECUTIVE~~ THE GOVERNING BODY OF THE COUNTY, AS PROVIDED BY THE  
22 COUNTY CHARTER; OR

27           (I) "MANAGEMENT EMPLOYEE" MEANS AN EMPLOYEE WHO GENERALLY  
28 HAS AUTHORITY AND WHO:

29                           (1) FORMULATES POLICY THAT IS APPLICABLE THROUGHOUT A  
30 BARGAINING UNIT;

1           **(2) HAS A SIGNIFICANT ROLE IN PERSONNEL ADMINISTRATION,**  
2 **EMPLOYEE RELATIONS, OR THE PREPARATION AND ADMINISTRATION OF BUDGETS**  
3 **FOR THE EMPLOYER; OR**

4           **(3) MAY REASONABLY BE REQUIRED TO:**

5                   **(I) ASSIST DIRECTLY IN THE PREPARATION FOR AND CONDUCT**  
6 **OF COLLECTIVE BARGAINING NEGOTIATIONS ON BEHALF OF THE EMPLOYER; OR**

7                   **(II) HAVE A MAJOR ROLE IN THE ADMINISTRATION OF**  
8 **RESULTING COLLECTIVE BARGAINING AGREEMENTS.**

9           **(J) (1) “PUBLIC LIBRARY SYSTEM” MEANS A COUNTY PUBLIC LIBRARY**  
10 **SYSTEM.**

11           **(2) “PUBLIC LIBRARY SYSTEM” INCLUDES THE ENOCH PRATT FREE**  
12 **LIBRARY.**

13           **(3) “PUBLIC LIBRARY SYSTEM” DOES NOT INCLUDE THE PUBLIC**  
14 **LIBRARY SYSTEM OF BALTIMORE COUNTY, MONTGOMERY COUNTY, OR PRINCE**  
15 **GEORGE’S COUNTY.**

16           **(K) “SUPERVISORY EMPLOYEE” MEANS AN EMPLOYEE WHO IS AUTHORIZED**  
17 **TO:**

18                   **(1) HIRE, TRANSFER, SUSPEND, LAY OFF, RECALL, PROMOTE,**  
19 **DISCHARGE, ASSIGN, REWARD, OR DISCIPLINE EMPLOYEES;**

20                   **(2) RESPONSIBLY DIRECT EMPLOYEES FOR MORE THAN 50% OF THE**  
21 **EMPLOYEE’S WORKING HOURS; OR**

22                   **(3) ADDRESS AND RESOLVE THE GRIEVANCES OF EMPLOYEES.**

23 **23-902.**

24           **(A) THERE MAY BE NOT MORE THAN TWO BARGAINING UNITS AT EACH**  
25 **PUBLIC LIBRARY SYSTEM INCLUDING:**

26                   **(1) ONE BARGAINING UNIT FOR EMPLOYEES; AND**

27                   **(2) ONE BARGAINING UNIT FOR SUPERVISORY EMPLOYEES.**

28           **(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**  
29 **BARGAINING UNIT MAY CONTAIN FULL-TIME OR PART-TIME EMPLOYEES.**

1           **(2) A BARGAINING UNIT MAY NOT INCLUDE VOLUNTEERS OR**  
2 **TEMPORARY EMPLOYEES WITH LESS THAN 90 DAYS OF SERVICE IN A 12-MONTH**  
3 **PERIOD.**

4           **(C) (1) THIS SUBTITLE MAY NOT BE CONSTRUED TO MODIFY OR**  
5 **TERMINATE A BARGAINING UNIT THAT WAS RECOGNIZED OR IN EXISTENCE ON OR**  
6 **BEFORE JUNE 30, 2024.**

7           **(2) (I) IF AN EMPLOYEE ORGANIZATION HAS BEEN CERTIFIED**  
8 **UNDER STATE OR LOCAL LAW ON OR BEFORE JUNE 30, 2024, TO BE AN EXCLUSIVE**  
9 **REPRESENTATIVE OF EMPLOYEES OF A PUBLIC LIBRARY SYSTEM, THE EMPLOYER**  
10 **SHALL ACCRETE ALL ELIGIBLE POSITIONS INTO THE EXISTING BARGAINING UNIT IN**  
11 **ACCORDANCE WITH THIS SECTION ON REQUEST OF THE EXCLUSIVE**  
12 **REPRESENTATIVE.**

13           **(II) AN ACCRETION UNDER THIS SUBSECTION SHALL BE**  
14 **SUBJECT TO A SHOWING OF INTEREST AND ELECTION BY EMPLOYEES IN THE**  
15 **ACCREDITED POSITIONS IN ACCORDANCE WITH THE PROCEDURES UNDER § 23-907 OF**  
16 **THIS TITLE.**

17 **23-903.**

18           **(A) AN EMPLOYEE WHO MAY EFFECTIVELY RECOMMEND AN ACTION LISTED**  
19 **IN § 23-901(I) OF THIS SUBTITLE MAY BE DEEMED A MANAGEMENT EMPLOYEE IF**  
20 **THE EMPLOYEE'S EXERCISE OF THE AUTHORITY REQUIRES THE EXERCISE OF**  
21 **INDEPENDENT JUDGMENT AND IS NOT MERELY OF A ROUTINE OR CLERICAL**  
22 **NATURE.**

23           **(B) THE EXERCISE OF ANY SINGLE FUNCTION LISTED IN § 23-901(I) OF THIS**  
24 **SUBTITLE MAY NOT NECESSARILY REQUIRE THE CONCLUSION THAT THE**  
25 **INDIVIDUAL EXERCISING THAT FUNCTION IS IN FACT A MANAGEMENT EMPLOYEE**  
26 **WITHIN THE MEANING OF THE DEFINITION.**

27           **(C) IN DIFFERENTIATING A MANAGEMENT EMPLOYEE FROM A**  
28 **NONMANAGEMENT EMPLOYEE:**

29           **(1) A CLASS TITLE ALONE MAY NOT BE THE BASIS FOR**  
30 **DETERMINATION; AND**

31           **(2) THE NATURE OF THE MANAGEMENT EMPLOYEE'S WORK,**  
32 **INCLUDING WHETHER A SIGNIFICANT PORTION OF THE MANAGEMENT EMPLOYEE'S**  
33 **WORKING TIME IS SPENT AS PART OF A TEAM THAT INCLUDES NONMANAGEMENT**  
34 **EMPLOYEES, SHALL BE CONSIDERED.**

1 **23-904.**

2 **EMPLOYEES OF THE EMPLOYER MAY:**

3 **(1) FORM, JOIN, AND PARTICIPATE IN AN EMPLOYEE ORGANIZATION;**

4 **(2) BARGAIN COLLECTIVELY THROUGH A CERTIFIED EXCLUSIVE**  
5 **REPRESENTATIVE OF THEIR CHOICE;**

6 **(3) ENGAGE IN LAWFUL CONCERTED ACTIVITIES FOR THEIR MUTUAL**  
7 **AID AND PROTECTION; AND**

8 **(4) REFRAIN FROM ANY ACTIVITY COVERED UNDER ITEMS (1)**  
9 **THROUGH (3) OF THIS SECTION.**

10 **23-905.**

11 **(A) THE EMPLOYER AND THE CERTIFIED EXCLUSIVE REPRESENTATIVE**  
12 **HAVE A RESPONSIBILITY TO ENGAGE IN GOOD FAITH BARGAINING OVER MATTERS**  
13 **REQUIRED BY LAW.**

14 **(B) THE EMPLOYER AND THE CERTIFIED EXCLUSIVE REPRESENTATIVE**  
15 **JOINTLY SHALL BE RESPONSIBLE FOR FOSTERING A POSITIVE LABOR RELATIONS**  
16 **ENVIRONMENT BASED ON MUTUAL TRUST, RESPECT, COMMUNICATION, AND**  
17 **COOPERATION.**

18 **(C) THE GOAL OF COLLECTIVE BARGAINING IS THE DELIVERY OF QUALITY**  
19 **PUBLIC SERVICES TO THE RESIDENTS OF THE STATE IN A MANNER THAT IS**  
20 **CONSISTENT AND COMPLIANT WITH LAW.**

21 **23-906.**

22 **(A) THE EMPLOYER SHALL RECOGNIZE THE RIGHT OF THE CERTIFIED**  
23 **EXCLUSIVE REPRESENTATIVE TO REPRESENT THE EMPLOYEES IN THE UNIT IN**  
24 **COLLECTIVE BARGAINING AND IN THE GRIEVANCE PROCESS.**

25 **(B) THE CERTIFIED EXCLUSIVE REPRESENTATIVE OF A UNIT SHALL:**

26 **(1) SERVE AS THE SOLE AGENT FOR THE UNIT IN COLLECTIVE**  
27 **BARGAINING; AND**

28 **(2) REPRESENT ALL EMPLOYEES IN THE UNIT FAIRLY AND IN GOOD**  
29 **FAITH, IN A MANNER THAT IS NOT ARBITRARY OR DISCRIMINATORY.**

2 (A) (1) AN EMPLOYEE ORGANIZATION SEEKING CERTIFICATION AS THE  
3 EXCLUSIVE REPRESENTATIVE FOR THE BARGAINING UNIT OF EMPLOYEES MAY FILE  
4 A PETITION WITH THE EMPLOYER INDICATING THIS INTENT.

5 (2) THE PETITION SHALL CONTAIN:

6 (I) A REQUEST THAT THE EMPLOYER RECOGNIZE THE  
7 EMPLOYEE ORGANIZATION AS THE EXCLUSIVE REPRESENTATIVE OF THE  
8 EMPLOYEES IN THE BARGAINING UNIT;

9 (II) A STATEMENT THAT THE EMPLOYEE ORGANIZATION IS ONE  
10 IN WHICH EMPLOYEES PARTICIPATE AND THAT HAS AS ONE OF ITS PURPOSES THE  
11 REPRESENTATION OF PUBLIC EMPLOYEES IN MATTERS OF WAGES, HOURS, AND  
12 OTHER TERMS AND CONDITIONS OF EMPLOYMENT;

13 (III) A STATEMENT THAT THE EMPLOYEE ORGANIZATION HAS NO  
14 TERMS OR CONDITIONS OF MEMBERSHIP THAT DISCRIMINATE WITH REGARD TO  
15 RACE, COLOR, CREED, GENDER, AGE, POLITICAL AFFILIATION, NATIONAL ORIGIN,  
16 RELIGION, MARITAL STATUS, OR DISABILITY; AND

17 (IV) A STATEMENT THAT THE EMPLOYEE ORGANIZATION HAS IN  
18 ITS POSSESSION WRITTEN PROOF DATED NOT MORE THAN 18 MONTHS BEFORE THE  
19 DAY ON WHICH THE PETITION IS FILED ESTABLISHING THAT AT LEAST 30% OF THE  
20 EMPLOYEES IN THE BARGAINING UNIT:

21 1. HAVE DESIGNATED THE EMPLOYEE ORGANIZATION  
22 TO REPRESENT THEM IN THEIR EMPLOYMENT RELATIONS WITH THE EMPLOYER; OR

23 2. ARE MEMBERS OF THE EMPLOYEE ORGANIZATION.

24 (3) BEFORE A PETITION MAY BE PROCESSED, THE PROOF OF  
25 INTEREST SUBMITTED SHALL BE VERIFIED AS PROVIDED IN THIS SECTION.

26 (4) THE EMPLOYEE ORGANIZATION AND THE EMPLOYER SHALL  
27 EQUALLY BEAR ANY COSTS ASSOCIATED WITH THE VERIFICATION.

28 (B) (1) (I) WHEN AN EMPLOYEE ORGANIZATION OR EMPLOYEES IN A  
29 BARGAINING UNIT FILE A PETITION WITH THE EMPLOYER, THE EMPLOYEE  
30 ORGANIZATION OR EMPLOYEES SHALL SELECT A NEUTRAL DECISION MAKER FROM  
31 A REFERRAL OR LIST OF ARBITRATORS PROVIDED BY THE FEDERAL MEDIATION  
32 AND CONCILIATION SERVICE.

1           **(II) THE EMPLOYEE ORGANIZATION OR EMPLOYEES IN THE**  
2 **BARGAINING UNIT SHALL SUBMIT TO THE NEUTRAL DECISION MAKER SELECTED**  
3 **UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH THE AUTHORIZATION CARDS**  
4 **SIGNED AND DATED BY AT LEAST 30% OF THE EMPLOYEES IN THE BARGAINING UNIT**  
5 **NOT MORE THAN 18 MONTHS BEFORE THE DAY THE PETITION WAS FILED**  
6 **INDICATING, AS APPROPRIATE, THAT THE EMPLOYEES HAVE DESIGNATED THE**  
7 **EMPLOYEE ORGANIZATION TO REPRESENT THEM IN THEIR EMPLOYMENT**  
8 **RELATIONS WITH THE PUBLIC LIBRARY SYSTEM ADMINISTRATION.**

9           **(2) THE EMPLOYEE ORGANIZATION SHALL COPY THE EMPLOYER ON**  
10 **THE REQUEST FOR A NEUTRAL DECISION MAKER IN ORDER FOR THE PUBLIC**  
11 **LIBRARY SYSTEM TO RECEIVE NOTICE OF THE SELECTION OF THE NEUTRAL**  
12 **DECISION MAKER FOR THE CERTIFICATION PROCESS.**

13           **(C) (1) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH,**  
14 **WITHIN 2 CALENDAR DAYS AFTER THE DAY ON WHICH THE EMPLOYER RECEIVES**  
15 **THE PETITION, THE EMPLOYER SHALL SUBMIT TO THE EMPLOYEE ORGANIZATION**  
16 **AND NEUTRAL DECISION MAKER:**

17                   **1. A LIST OF EMPLOYEES IN THE BARGAINING UNIT**  
18 **THAT IDENTIFIES EACH EMPLOYEE THAT THE EMPLOYER CONTENDS SHOULD BE**  
19 **EXCLUDED AS AN ELIGIBLE VOTER OR FROM THE BARGAINING UNIT; AND**

20                   **2. A STATEMENT EXPLAINING THE REASON FOR EACH**  
21 **EXCLUSION.**

22           **(II) IF A NEUTRAL DECISION MAKER HAS NOT BEEN SELECTED**  
23 **WHEN THE EMPLOYER IS REQUIRED TO SUBMIT THE LIST REQUIRED UNDER**  
24 **SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE EMPLOYER SHALL INSTEAD SUBMIT**  
25 **THE LIST WITHIN 1 CALENDAR DAY AFTER THE NEUTRAL DECISION MAKER HAS**  
26 **BEEN SELECTED.**

27           **(III) IF THE EMPLOYER FAILS TO PROVIDE AN EXPLANATION AS**  
28 **REQUIRED UNDER ITEM (I)2 OF THIS PARAGRAPH, THE EMPLOYER MAY NOT**  
29 **CHALLENGE THE ELIGIBILITY OF AN EMPLOYEE'S VOTE IN AN ELECTION OR THE**  
30 **ELIGIBILITY TO SUBMIT A SHOWING OF INTEREST FORM FOR PURPOSES OF**  
31 **SUBSECTION (D)(3) OF THIS SECTION.**

32           **(2) IF THE EMPLOYER FAILS TO SUBMIT THE LIST OF EMPLOYEES TO**  
33 **THE EMPLOYEE ORGANIZATION OR NEUTRAL DECISION MAKER WITHIN THE**  
34 **REQUIRED TIME, IT SHALL BE CONCLUSIVELY DEEMED THAT AT LEAST 30% OF THE**  
35 **EMPLOYEES IN THE BARGAINING UNIT HAVE INDICATED A DESIRE TO BE**  
36 **REPRESENTED BY THE EMPLOYEE ORGANIZATION.**



1           **(D) (1) THE NEUTRAL DECISION MAKER SHALL CHECK THE WRITTEN**  
2 **AUTHORIZATION CARDS SUBMITTED BY THE EMPLOYEE ORGANIZATION OR THE**  
3 **EMPLOYEES AGAINST THE LIST OF EMPLOYEES SUBMITTED BY THE EMPLOYER.**

4           **(2) IF THE NEUTRAL DECISION MAKER DETERMINES THAT AT LEAST**  
5 **30% OF THE EMPLOYEES ON THE LIST HAVE INDICATED A DESIRE TO BE**  
6 **REPRESENTED BY THE EMPLOYEE ORGANIZATION OR TO DECERTIFY AN EXCLUSIVE**  
7 **REPRESENTATIVE, THE NEUTRAL DECISION MAKER SHALL NOTIFY THE EMPLOYER**  
8 **OF THE DETERMINATION.**

9           **(3) IF THE EMPLOYEE ORGANIZATION SUBMITS A SHOWING OF**  
10 **INTEREST OF AT LEAST 50% OF THE EMPLOYEES IN AN UNREPRESENTED**  
11 **BARGAINING UNIT:**

12                   **(I) THE NEUTRAL DECISION MAKER SHALL ISSUE TO EACH**  
13 **PARTICIPANT IN AN ELECTION A CERTIFICATION OF REPRESENTATION; AND**

14                   **(II) THE EMPLOYER SHALL RECOGNIZE THE EMPLOYEE**  
15 **ORGANIZATION AS THE CERTIFIED BARGAINING REPRESENTATIVE OF THE**  
16 **EMPLOYEES AT ISSUE.**

17           **(E) AN ELECTION MAY NOT BE CONDUCTED IN A BARGAINING UNIT UNLESS**  
18 **AT LEAST 1 YEAR HAS PASSED SINCE THE LAST ELECTION HELD IN THE BARGAINING**  
19 **UNIT.**

20           **(F) (1) THE EMPLOYER SHALL NOTIFY ALL EMPLOYEES WITHIN THE**  
21 **PROPOSED BARGAINING UNIT THAT AN ELECTION WILL BE HELD AND REQUEST A**  
22 **NEUTRAL DECISION MAKER FROM THE FEDERAL MEDIATION AND CONCILIATION**
