A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Alcoholic Beverages – Nonprofit Performing Arts Theater**
3 **License**

4 FOR the purpose of establishing in St. Mary's County a nonprofit performing arts theater
5 beer and wine license that authorizes the holder to sell or serve beer and wine in
6 certain nonprofit performing arts theaters at retail for on-premises consumption;
7 and generally relating to alcoholic beverages in St. Mary's County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages and Cannabis**

21 28–102.

22 This title applies only in St. Mary's County.

23 **28–1004.**

1 **(A) IN THIS SECTION, “NONPROFIT PERFORMING ARTS THEATER” MEANS**
2 **AN AREA, A BUILDING, OR A STRUCTURE DESIGNED AND USED FOR PLAYS, ACTS,**
3 **DRAMAS, CONCERTS, OR SIMILAR EVENTS BY INDIVIDUALS PERFORMING ON A**
4 **STAGE.**

5 **(B) THERE IS A NONPROFIT PERFORMING ARTS THEATER BEER AND WINE**
6 **LICENSE.**

7 **(C) (1) THE BOARD MAY ISSUE THE LICENSE FOR USE ON THE PREMISES**
8 **OF A PERFORMING ARTS THEATER THAT:**

9 **(I) HAS SEATING; AND**

10 **(II) IS OPERATED BY A NONPROFIT ORGANIZATION.**

11 **(2) THE PRESIDENT AND TWO OTHER OFFICERS OF THE NONPROFIT**
12 **PERFORMING ARTS THEATER SHALL SIGN THE APPLICATION FOR THE LICENSE.**

13 **(D) THE LICENSE AUTHORIZES THE HOLDER TO SELL OR SERVE BEER AND**
14 **WINE AT RETAIL FOR ON-PREMISES CONSUMPTION.**

15 **(E) THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE FROM 1**
16 **HOUR BEFORE TO 1 HOUR AFTER:**

17 **(1) A REGULAR PERFORMANCE; OR**

18 **(2) A FUND-RAISER PERFORMANCE THAT BENEFITS THE NONPROFIT**
19 **PERFORMING ARTS THEATER.**

20 **(F) THE LICENSE HOLDER MAY PURCHASE BEER AND WINE FROM A RETAIL**
21 **LICENSE HOLDER OR A LICENSED WHOLESALER.**

22 **(G) THE ANNUAL LICENSE FEE IS \$300.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2024.
