- 8 (c) The provision of services or facilities by a telephone company under a tariff 9 approved by the Public Service Commission is not a violation of subsection (b) of this section 10 relating to recorded telephone messages.
- 11 (d) A person who violates this section is guilty of a misdemeanor and on conviction 12 is subject to:
- 13 (1) for a first violation, imprisonment not exceeding 1 year or a fine not 14 exceeding \$1,000 or both; and
- 15 (2) for each subsequent violation, imprisonment not exceeding 3 years or a 16 fine not exceeding \$5,000 or both.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
