- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 4 INCLUDES:
- 5 1. ESTABLISHING PARTNERSHIPS WITH
- 6 COMMUNITY-BASED ORGANIZATIONS, LOCAL SCHOOL SYSTEMS, OR SPECIFIC HIGH

- 20 SHALL ADOPT AND ANNUALLY UPDATE A WRITTEN POLICY THAT IDENTIFIES
- 21 COMMUNITIES OF INTEREST IN THE STATE AND THE INSTITUTION'S TARGETED
- 22 RECRUITMENT AND OUTREACH EFFORTS FOR THE COMMUNITY OF INTEREST WITH
- 23 THE GOAL OF MEETING THE PRINCIPLE OF PUBLIC HIGHER EDUCATION STATED IN

- 25 (2) EACH PUBLIC SENIOR HIGHER EDUCATION INSTITUTION SHALL
- 26 COMPLETE THE TARGETED RECRUITMENT AND OUTREACH EFFORTS IDENTIFIED IN
- 27 PARAGRAPH (1) OF THIS SUBSECTION EACH YEAR.
- 28 (C) (D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS
- 29 SUBSECTION, ON OR BEFORE AUGUST 1, 2024, AND EACH AUGUST 1 THEREAFTER,
- 30 EACH PUBLIC SENIOR HIGHER EDUCATION INSTITUTION SHALL REPORT TO THE
- 31 GOVERNOR AND, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT
- 32 ARTICLE, THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE ON:

9 10	(IV) APPLICATION AND ADMISSION DATA FOR INDIVIDUALS IN EACH IDENTIFIED COMMUNITY OF INTEREST.
11 12 13	(2) THE REPORT SUBMITTED BY AN INSTITUTION ON OR BEFORE AUGUST 1, 2024, IS NOT REQUIRED TO INCLUDE THE INFORMATION REQUIRED IN PARAGRAPH (1)(II) OF THIS SUBSECTION.
14 15	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, $2024$ .
