A BILL ENTITLED

1 AN ACT concerning

2 **General Provisions – State Flag – Casket of an Eligible Decedent**

3 FOR the purpose of requiring the Secretary of State to furnish a State flag to drape the
4 casket of an eligible decedent; establishing the process for a State flag to be claimed
5 after burial; prohibiting the Secretary of State from procuring a certain flag; and
6 generally relating to the burial of an eligible decedent.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – General Provisions**

15 **7–207.**

16 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
17 **INDICATED.**

18 **(2) “ELIGIBLE DECEDENT” MEANS:**

19 **(I) AN EMPLOYEE OF THE STATE OR ANY POLITICAL**
20 **SUBDIVISION WHO DIED AS A RESULT OF:**

21 **1. AN ACCIDENTAL INJURY THAT AROSE OUT OF AND IN**
22 **THE COURSE OF EMPLOYMENT WITH THE STATE OR POLITICAL SUBDIVISION; OR**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **2. AN INJURY CAUSED BY A WILLFUL OR NEGLIGENT ACT**
2 **OF A THIRD PERSON, DIRECTED AGAINST THE EMPLOYEE IN THE COURSE OF**
3 **EMPLOYMENT WITH THE STATE OR POLITICAL SUBDIVISION;**

4 **(II) A CURRENT OR FORMER CONSTITUTIONAL OFFICER, AS**
5 **DEFINED IN § 29–305 OF THE STATE PERSONNEL AND PENSIONS ARTICLE;**

6 **(III) A CURRENT OR FORMER MEMBER OF THE GENERAL**
7 **ASSEMBLY;**

8 **(IV) A JUDGE, AS DEFINED IN § 1–101 OF THE COURTS ARTICLE;**

9 **(V) AN INDIVIDUAL WHO CURRENTLY HOLDS OR FORMERLY**
10 **HELD ANY OF THE POSITIONS IDENTIFIED IN § 29–304 OF THE STATE PERSONNEL**
11 **AND PENSIONS ARTICLE; OR**

12 **(VI) ANY OTHER INDIVIDUAL WHOM THE GOVERNOR**
13 **DESIGNATES THROUGH AN EXECUTIVE ORDER.**

14 **(3) “POLITICAL SUBDIVISION” HAS THE MEANING STATED IN § 4–101**
15 **OF THIS ARTICLE.**

16 **(4) “WHOLLY PRODUCED IN THE UNITED STATES” MEANS A FLAG**
17 **THAT CONTAINS ONLY:**

18 **(I) MATERIALS AND COMPONENTS THAT ARE GROWN,**
19 **MANUFACTURED, OR CREATED ENTIRELY IN THE UNITED STATES;**

20 **(II) PROCESSING COMPONENTS, INCLUDING SPINNING,**
21 **WEAVING, DYEING, AND FINISHING, THAT ARE PERFORMED ENTIRELY IN THE**
22 **UNITED STATES; AND**

23 **(III) MATERIALS THAT HAVE BEEN MANUFACTURED AND**
24 **ASSEMBLED ENTIRELY IN THE UNITED STATES.**

25 **(B) THE SECRETARY OF STATE SHALL FURNISH A STATE FLAG TO DRAPE**
26 **THE CASKET OF AN ELIGIBLE DECEDENT.**

27 **(C) (1) AFTER THE BURIAL OF AN ELIGIBLE DECEDENT, THE FLAG SHALL**
28 **BE:**

29 **(I) CLAIMED BY AND PROVIDED TO THE ELIGIBLE DECEDENT’S**

1 NEXT OF KIN; OR

2 (II) PROVIDED TO A CLOSE FRIEND OR AN ASSOCIATE, IF IT IS
3 NOT CLAIMED BY THE ELIGIBLE DECEDENT'S NEXT OF KIN.

4 (2) ONLY ONE FLAG MAY BE PROVIDED FOR THE DEATH OF AN
5 ELIGIBLE DECEDENT UNDER THIS SECTION.

6 (D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,
7 THE SECRETARY OF STATE MAY NOT PROCURE ANY FLAG UNDER THIS SECTION
8 UNLESS IT IS WHOLLY PRODUCED IN THE UNITED STATES.

9 (2) THE SECRETARY OF STATE MAY WAIVE THE REQUIREMENT
10 UNDER PARAGRAPH (1) OF THIS SUBSECTION IF IT CANNOT BE MET REASONABLY.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2024.
