The Board may issue a general license to a limited licensee who was granted 15(d) 16 a waiver under this section if the limited licensee: 17(1)Successfully completes at least a 2-year contractual obligation to 18provide [pediatric] dental care in accordance with subsection (b)(1)(iv) of this section; 19(2)Submits an application for a general license to practice dentistry on a 20form provided by the Board; 21(3)Passes the ADLEX as defined in § 4-306(a)(4) of this subtitle; 22(4)Passes the Maryland Dental Jurisprudence Examination given by the 23Board or its designee; 24Passes the National Board Examinations; (5)25(6)Demonstrates oral English competency by scoring 220 or better for 26overall comprehension and 2.0 or better for pronunciation, grammar, and fluency on the test of spoken English administered by the Educational Testing Service; and 2728Is found to be of good moral character. (7)294 - 308.30 (b) While it is effective, a limited license to practice dentistry issued under this 31title authorizes the licensee to practice dentistry, including as an intern or a resident:
