13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 16 (A) THERE IS A FINANCIAL WELL-BEING PILOT PROGRAM AT THE

- 19 (B) THE PURPOSE OF THE PILOT PROGRAM IS TO PROVIDE
- 20 COMPREHENSIVE FINANCIAL GUIDANCE, SUPPORT, AND COACHING TO HELP
- 21 STUDENTS WHO MAY BENEFIT FROM FINANCIAL COACHING SERVICES.

- 1 (B) EACH PARTICIPATING INSTITUTION OF HIGHER EDUCATION SHALL
- 2 CREATE A SYSTEM THAT ALLOWS THE INSTITUTION OF HIGHER EDUCATION TO
- 3 IDENTIFY ENROLLED AND ADMITTED STUDENTS WHO MAY BENEFIT FROM
- 4 FINANCIAL COACHING SERVICES.

- 6 (A) A FINANCIAL WELL-BEING COACH SHALL:
- 7 (1) (I) ASSIST STUDENTS IN UNDERSTANDING THE STUDENTS'
- 8 PERSONAL FINANCIAL NEEDS AND RESOURCES;
- 9 (II) ASSIST STUDENTS IN THE PROCESS OF MAKING INFORMED
- 10 PERSONAL FINANCIAL DECISIONS:
- 11 (III) SHARE RELEVANT FINANCIAL LITERACY RESOURCES WITH
- 12 STUDENTS; AND
- 13 (IV) ASSIST STUDENTS IN MANAGING PERSONAL FINANCIAL
- 14 OBLIGATIONS DURING COLLEGE AND AFTER GRADUATION;
- 15 (2) WHILE PROVIDING THE SUPPORT SERVICES LISTED IN ITEM (1)
- 16 OF THIS SUBSECTION, FOCUS ON:
- 17 (I) THE BEHAVIORAL AND EMOTIONAL ASPECTS OF PERSONAL
- 18 FINANCES; AND
- 19 (II) HOW A STUDENT CAN SUCCESSFULLY ACHIEVE PERSONAL
- 20 FINANCIAL GOALS AND ESTABLISH HEALTHY FINANCIAL HABITS;
- 21 (3) CARRY A CASELOAD THAT IS COMPARABLE TO THE CASELOAD OF
- 22 AN ACADEMIC ADVISOR AT THE PARTICIPATING INSTITUTION OF HIGHER
- 23 EDUCATION:
- 24 (4) SURVEY EACH STUDENT BEFORE THE STUDENT BEGINS
- 25 FINANCIAL COACHING SERVICES AND AFTER THE STUDENT COMPLETES FINANCIAL
- 26 COACHING SERVICES AND EVALUATE THE EFFECTIVENESS OF THE FINANCIAL
- 27 COACHING SERVICES; AND
- 28 (5) At the end of the Pilot Program, create a document
- 29 WITH BEST PRACTICES, PROCESSES, AND GUIDANCE THAT OTHER INSTITUTIONS OF
- 30 HIGHER EDUCATION CAN USE TO CREATE A FINANCIAL WELL-BEING COACHING
- 31 PROGRAM.

- 1 (B) (1) A FINANCIAL WELL-BEING COACH MAY PROVIDE FINANCIAL 2 COACHING SERVICES TO STUDENTS IN THE FOLLOWING SETTINGS:
- 3 (I) GROUP COACHING SESSIONS;
- 4 (II) INDIVIDUAL COACHING SESSIONS; AND
- 5 (III) DURING THE FINANCIAL WELL-BEING COACH'S DROP-IN 6 ADVISORY HOURS.
- 7 (2) WHEN SCHEDULING INDIVIDUAL COACHING SESSIONS, A 8 FINANCIAL WELL-BEING COACH SHALL PRIORITIZE STUDENTS WHO:
- 9 (I) MOST LIKELY WILL HAVE A DEBT TO POTENTIAL FUTURE 10 INCOME RATIO THAT WILL LEAD TO A MONTHLY LOAN PAYMENT GREATER THAN 10%
- 11 OF THE STUDENT'S PROJECTED FUTURE INCOME;
- 12 (II) HAVE AN ANNUAL HOUSEHOLD INCOME THAT IS AT OR
- 13 BELOW 185% OF THE FEDERAL POVERTY LEVEL AS DETERMINED ANNUALLY BY THE
- 14 U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES; OR
- 15 (III) LACK FINANCIAL SKILLS AND FINANCIAL LITERACY
- 16 EDUCATION.

- 18 (A) (1) ON OR BEFORE JUNE 1, 2025, EACH PARTICIPATING INSTITUTION
- 19 OF HIGHER EDUCATION SHALL SUBMIT AN INTERIM REPORT TO THE COMMISSION
- 20 ON THE STATUS AND EFFECTIVENESS OF THE PILOT PROGRAM.
- 21 (2) ON OR BEFORE JUNE 1, 2026, EACH PARTICIPATING INSTITUTION
- 22 OF HIGHER EDUCATION SHALL SUBMIT A FINAL REPORT TO THE COMMISSION ON
- 23 THE STATUS AND EFFECTIVENESS OF THE PILOT PROGRAM.
- 24 (B) On or before July 1, 2025, the Commission shall submit an
- 25 INTERIM REPORT TO EACH INSTITUTION OF HIGHER EDUCATION IN THE STATE, THE
- 26 GOVERNOR, AND, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT
- 27 ARTICLE, THE GENERAL ASSEMBLY ON THE OPERATION OF THE PILOT PROGRAM.
- 28 (C) ON OR BEFORE JULY 1, 2026, THE COMMISSION SHALL SUBMIT A FINAL
- 29 REPORT TO EACH INSTITUTION OF HIGHER EDUCATION IN THE STATE, THE
- 30 GOVERNOR, AND, IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT

- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 - 1, 2024. It shall remain effective for a period of 3 years and 1 month and, at the end of July
- 5 31, 2027, this Act, with no further action required by the General Assembly, shall be
- 6 abrogated and of no further force and effect.
