AND BE IT FURTHER ENACTED, That, notwithstanding § 26–1802 of the Alcoholic Beverages and Cannabis Article, a <u>Class B</u> license or permit issued by the Board of License Commissioners for Prince George's County that was subject to renewal from March 5, 2020, to December 31, 2023, both inclusive, and was not renewed because the holder failed to file a renewal application, shall be considered unexpired until July 1, 2025, and may be renewed to bring the license up–to–date if the license holder :

25	(2) <u>the license holder pays all past due fees; and</u>
