1 (2) "NETWORK" MEANS A STUDENT SUPPORT SPECIALIST 2 NETWORK.

(3) "PLAN" MEANS A STUDENT SUPPORT SUCCESS ACTION PLAN.

4 (4) "TEMPLATE" MEANS THE TEMPLATE DEVELOPED BY THE PRINCE 5 GEORGE'S COUNTY BOARD OF EDUCATION USED BY A STUDENT SUPPORT 6 SPECIALIST NETWORK.

7 (B) THIS SECTION APPLIES ONLY IN PRINCE GEORGE'S COUNTY.

8 (C) THERE IS A STUDENT SUPPORT SPECIALIST NETWORK IN EACH PUBLIC 9 HIGH SCHOOL IN THE COUNTY.

BEFORE IMPLEMENTING A PLAN IN ACCORDANCE WITH 16(G) (1) SUBSECTION (F) OF THIS SECTION, EACH NETWORK SHALL SUBMIT THE PLAN TO 17THE COUNTY BOARD FOR APPROVAL. 18 19(2) THE DEADLINE FOR SUBMISSION SHALL BE DETERMINED BY THE 20**COUNTY BOARD.** ON OR BEFORE JULY 1, 2025, AND ON OR BEFORE EACH JULY 1 21**(H)** THEREAFTER, EACH NETWORK SHALL REPORT THE RESULTS OF 22THE 23IMPLEMENTATION OF THE NETWORK'S PLAN TO THE COUNTY BOARD. 24SECTION 2.
