Health - Abortion - Ultrasound and Waiting Period

- FOR the purpose of prohibiting a qualified provider from performing or inducing an abortion on a pregnant woman within a certain period of time after the woman receives certain ultrasound imaging; establishing certain requirements related to the performance of a certain transabdominal ultrasound; providing that a woman is not required to accept anything offered during certain transabdominal ultrasound imaging; and generally relating to an ultrasound and waiting period before the performance of an abortion.
