A BILL ENTITLED

1 AN ACT concerning

2 **Health – Abortion – Ultrasound and Waiting Period**

3 FOR the purpose of prohibiting a qualified provider from performing or inducing an
4 abortion on a pregnant woman within a certain period of time after the woman
5 receives certain ultrasound imaging; establishing certain requirements related to
6 the performance of a certain transabdominal ultrasound; providing that a woman is
7 not required to accept anything offered during certain transabdominal ultrasound
8 imaging; and generally relating to an ultrasound and waiting period before the
9 performance of an abortion.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Health – General**

23 20–209.

24 (a) In this section, “viable” means that stage when, in the best clinical judgment
25 of the qualified provider based on the particular facts of the case before the qualified

1 provider, there is a reasonable likelihood of the fetus's sustained survival outside the womb.

2 (b) Except as **PROVIDED IN § 20–210 OF THIS SUBTITLE OR AS** otherwise
3 provided in this subtitle, the State may not interfere with the decision of a woman to
4 terminate a pregnancy:

5 (1) Before the fetus is viable; or

6 (2) At any time during the woman's pregnancy, if:

7 (i) The termination procedure is necessary to protect the life or
8 health of the woman; or

9 (ii) The fetus is affected by genetic defect or serious deformity or
10 abnormality.

11 (c) The Department may adopt regulations that:

12 (1) Are both necessary and the least intrusive method to protect the life or
13 health of the woman; and

14 (2) Are not inconsistent with established clinical practice.

15 (d) The qualified provider is not liable for civil damages or subject to a criminal
16 penalty for a decision to perform an abortion under this section made in good faith and in
17 the qualified provider's best clinical judgment in accordance with accepted standards of
18 clinical practice **AND § 20–210 OF THIS SUBTITLE.**

19 **20–210.**

20 **(A) THIS SECTION DOES NOT APPLY TO A WOMAN SEEKING AN ABORTION IF:**

21 **(1) THE WOMAN IS THE VICTIM OF AN ALLEGED RAPE OR OF INCEST,**
22 **AS PROHIBITED UNDER § 3–323 OF THE CRIMINAL LAW ARTICLE; AND**

23 **(2) THE INCIDENT OF RAPE OR INCEST IS REPORTED TO LAW**
24 **ENFORCEMENT.**

25 **(B) A QUALIFIED PROVIDER MAY NOT PERFORM OR INDUCE AN ABORTION**
26 **ON A PREGNANT WOMAN:**

27 **(1) WITHIN 24 HOURS AFTER THE WOMAN RECEIVES**
28 **TRANSABDOMINAL ULTRASOUND IMAGING IN ACCORDANCE WITH SUBSECTION (C)**
29 **OF THIS SECTION; OR**

1 **(2) IF THE WOMAN RESIDES AT LEAST 100 MILES FROM THE FACILITY**
2 **IN WHICH THE ABORTION WILL BE PERFORMED, WITHIN 2 HOURS AFTER THE**
3 **WOMAN RECEIVES TRANSABDOMINAL ULTRASOUND IMAGING IN ACCORDANCE WITH**
4 **SUBSECTION (C) OF THIS SECTION.**

5 **(C) THE MEDICAL PROFESSIONAL PERFORMING THE TRANSABDOMINAL**
6 **ULTRASOUND IMAGING REQUIRED UNDER SUBSECTION (B) OF THIS SECTION MUST:**

7 **(1) BE TRAINED IN SONOGRAPHY AND WORKING UNDER THE**
8 **SUPERVISION OF A QUALIFIED PROVIDER;**

9 **(2) IF POSSIBLE, DETERMINE THE GESTATIONAL AGE OF THE FETUS**
10 **BASED ON:**

11 **(I) MEASUREMENT OF THE FETUS IN A MANNER CONSISTENT**
12 **WITH THE STANDARD OF CARE; OR**

13 **(II) IF ONLY THE GESTATIONAL SAC IS VISIBLE DURING THE**
14 **TRANSABDOMINAL ULTRASOUND IMAGING, MEASUREMENT OF THE GESTATIONAL**
15 **SAC;**

16 **(3) IF GESTATIONAL AGE CANNOT BE DETERMINED UNDER ITEM (2)**
17 **OF THIS SUBSECTION, VERBALLY OFFER TO THE WOMAN OTHER ULTRASOUND**
18 **IMAGING TO DETERMINE GESTATIONAL AGE OF THE FETUS;**

19 **(4) IF PRESENT AND VIEWABLE, INCLUDE IN THE ULTRASOUND**
20 **IMAGE:**

21 **(I) THE DIMENSIONS OF THE FETUS; AND**

22 **(II) AN ACCURATE PORTRAYAL OF THE PRESENCE OF**
23 **EXTERNAL MEMBERS AND INTERNAL ORGANS OF THE FETUS;**

24 **(5) MAKE A PRINT OF THE ULTRASOUND IMAGE TO DOCUMENT ANY**
25 **MEASUREMENTS TAKEN TO DETERMINE THE GESTATIONAL AGE OF THE FETUS;**

26 **(6) VERBALLY OFFER TO THE WOMAN DURING THE**
27 **TRANSABDOMINAL ULTRASOUND IMAGING THE OPTION TO:**

28 **(I) VIEW THE ULTRASOUND IMAGE;**

29 **(II) RECEIVE A PRINTED COPY OF THE ULTRASOUND IMAGE;**

30 **AND**

1 **(III) HEAR THE FETAL HEARTBEAT IN A MANNER CONSISTENT**
2 **WITH THE STANDARD OF CARE; AND**

3 **(7) OBTAIN FROM THE WOMAN WRITTEN CERTIFICATION THAT:**

4 **(I) THE MEDICAL PROFESSIONAL PERFORMING THE**
5 **TRANSABDOMINAL ULTRASOUND IMAGING OFFERED OPTIONS AS REQUIRED UNDER**
6 **ITEM (6) OF THIS SUBSECTION; AND**

7 **(II) IF APPLICABLE, THE WOMAN RESIDES AT LEAST 100 MILES**
8 **FROM THE FACILITY IN WHICH THE ABORTION WILL BE PERFORMED.**

9 **(D) A WOMAN IS NOT REQUIRED TO ACCEPT ANYTHING OFFERED DURING**
10 **TRANSABDOMINAL ULTRASOUND IMAGING PERFORMED IN ACCORDANCE WITH**
11 **SUBSECTION (C) OF THIS SECTION, INCLUDING OFFERS MADE UNDER SUBSECTION**
12 **(C)(3) AND (6) OF THIS SECTION.**

13 **(E) THE FACILITY IN WHICH AN ABORTION IS PERFORMED SHALL MAINTAIN**
14 **A PRINTED COPY OF THE ULTRASOUND IMAGE MADE UNDER SUBSECTION (C)(5) OF**
15 **THIS SECTION FOR THE GREATER OF:**

16 **(1) 7 YEARS; OR**

17 **(2) AN AMOUNT OF TIME AS REQUIRED BY FEDERAL OR STATE LAW.**

18 **(F) A QUALIFIED PROVIDER WHO VIOLATES THIS SECTION IS SUBJECT TO A**
19 **PENALTY OF UP TO \$2,500.**

20 **(G) THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A QUALIFIED**
21 **PROVIDER FROM USING ULTRASOUND IMAGING THAT THE QUALIFIED PROVIDER**
22 **CONSIDERS MEDICALLY APPROPRIATE, CONSISTENT WITH THE STANDARD OF CARE.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2024.
