## A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education – Part–Time Senatorial and Delegate Scholarships –**  
3 **Alterations**

4 FOR the purpose of allowing an applicant of a part–time senatorial or delegate scholarship  
5 with a documented disability to request from the Maryland Higher Education  
6 Commission a waiver from the requirement to carry a certain number of semester  
7 hours each semester; and generally relating to part–time senatorial and delegate  
8 scholarships.

9 BY repealing and reenacting, without amendments,

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

21 **Article – Education**

22 18–401.

23 There is a program of senatorial scholarships in this State that are awarded under  
24 this subtitle.

1 18-406.

2 (a) Except as otherwise provided in this section, each recipient of a senatorial  
3 scholarship may hold the scholarship for 4 undergraduate academic years, subject to §  
4 18-406.1 of this subtitle, and 4 graduate academic years if the recipient:

5 (1) Is a full-time student;

6 (2) Continues to be eligible for in-State tuition under this article; and

7 (3) Continues to be a student at the institution and takes at least 12  
8 semester hours of courses as an undergraduate or 9 semester hours of courses as a graduate  
9 student each semester leading to a degree.

10 (b) A recipient of an undergraduate or graduate senatorial scholarship may hold  
11 the scholarship, appropriately prorated, for 8 academic years if the recipient:

12 (1) Is a part-time student;

13 (2) Continues to be eligible for in-State tuition under this article; and

14 (3) Continues to be a student at the institution and takes at least 6  
15 semester hours of courses each semester leading to a degree.

16 (c) Any recipient of a senatorial scholarship may use up to one-half of the yearly  
17 award for summer school.

18 (d) A recipient of a senatorial scholarship who is enrolled in a terminal certificate  
19 program as provided in § 18-402(a)(1) of this subtitle may hold the scholarship for 2 years  
20 if the recipient is a full-time student and otherwise meets the conditions of subsection (a)  
21 of this section, or may hold the scholarship for 4 years if the recipient is a part-time student  
22 and otherwise meets the conditions of subsection (b) of this section.

23 (e) A recipient of a senatorial scholarship who is currently enrolled, or was  
24 enrolled within the last 2 years, in a certificate or license program, course, or sequence of  
25 courses at a community college that leads to certification or licensure, as provided in §  
26 18-402(a)(3) of this subtitle, may use the scholarship to reimburse educational expenses as  
27 defined by the Office under § 18-405(b)(2) of this subtitle.

28 (f) Each recipient of a senatorial scholarship who is enrolled in a private  
29 postsecondary proprietary institution that is accredited by a national accrediting  
30 association approved by the United States Department of Education:

31 (1) May hold the scholarship for the completion of one program if the  
32 student otherwise meets the conditions of subsection (a)(1) and (2) of this section; and

1           (2)     Shall complete the program within the length of time prescribed by the  
2 institution for the completion of the program.

3           (g)     A recipient of a senatorial scholarship who is an individual who is on active  
4 duty with the United States military and otherwise meets the conditions of subsection (a)  
5 or (b) of this section may be domiciled in this State rather than eligible for in-State tuition  
6 under this article.

7           **(H)     ON REQUEST FROM AN APPLICANT OF THE SCHOLARSHIP WITH A**  
8 **DOCUMENTED DISABILITY, THE MARYLAND HIGHER EDUCATION COMMISSION MAY**  
9 **WAIVE THE REQUIREMENT IN SUBSECTION (B)(3) OF THIS SECTION.**

10 18-501.

11           (a)     There is a program of Delegate Scholarships in this State that are awarded  
12 under this subtitle.

13 18-504.

14           (a)     A Delegate may award two part-time scholarships for each full-time  
15 scholarship available.

16           (b)     A part-time scholarship may not be for more than twice as many years as a  
17 full-time scholarship.

18           (c)     Each recipient of a part-time scholarship shall carry at least 6 semester hours  
19 of courses each semester in a program leading to a degree.

20           **(D)     ON REQUEST FROM AN APPLICANT OF THE SCHOLARSHIP WITH A**  
21 **DOCUMENTED DISABILITY, THE MARYLAND HIGHER EDUCATION COMMISSION MAY**  
22 **WAIVE THE REQUIREMENT IN SUBSECTION (C) OF THIS SECTION.**

23           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
24 1, 2024.
