1 AN ACT concerning

2 **Consumer Protection – Self-Administered Sexual Assault Evidence Collection**  
3 **Kits**

4 FOR the purpose of providing that a party in a criminal trial involving an allegation of a  
5 ~~sexual crime~~ sexually assaultive behavior may not introduce ~~evidence~~ information  
6 that physical evidence of a ~~sexual crime~~ sexually assaultive behavior was obtained  
7 using certain materials; providing that selling, offering for sale, or distributing a  
8 certain self-administered sexual assault evidence collection kit is an unfair,  
9 deceptive, or abusive trade practice; establishing the Forensic Nurse Examiner  
10 Training Grant Program; establishing the Forensic Nurse Examiner Training Grant  
11 Program Fund as a special, nonlapsing fund; prohibiting the limitation or waiver of  
12 certain rights and warranties on certain products used to collect evidence of a sexual  
13 assault; and generally relating to self-administered sexual assault evidence  
14 collection kits.

21 **(A) THIS SECTION DOES NOT APPLY TO A SELF-ADMINISTERED SEXUAL**  
22 **ASSAULT EVIDENCE COLLECTION KIT THAT IS ISSUED BY THE MARYLAND**  
23 **DEPARTMENT OF HEALTH.**

24 **(B) A PERSON MAY NOT SELL, OFFER FOR SALE, OR DISTRIBUTE A**  
25 **SELF-ADMINISTERED SEXUAL ASSAULT EVIDENCE COLLECTION KIT.**

26 **(C) (1) A VIOLATION OF THIS SECTION IS:**

27 **(I) AN UNFAIR, ABUSIVE, OR DECEPTIVE TRADE PRACTICE**  
28 **WITHIN THE MEANING OF TITLE 13 OF THIS ARTICLE; AND**

1 (II) SUBJECT TO THE ENFORCEMENT AND PENALTY  
2 PROVISIONS CONTAINED IN TITLE 13 OF THIS ARTICLE.

3 (2) (I) IN ADDITION TO ANY PENALTY IMPOSED UNDER TITLE 13  
4 OF THIS ARTICLE, A PERSON WHO VIOLATES THIS SECTION IS SUBJECT TO A CIVIL  
5 PENALTY NOT EXCEEDING \$1,000 FOR EACH VIOLATION.

17 (A) THERE IS A FORENSIC NURSE EXAMINER TRAINING GRANT PROGRAM.

18 (B) THE PURPOSE OF THE PROGRAM IS TO ASSIST NONPROFIT ENTITIES  
19 THAT PROVIDE RESOURCES FOR VICTIMS OF SEXUAL ASSAULT IN THE STATE TO  
20 FUND TRAINING FOR NURSES IN THE STATE TO DEVELOP SKILLS IN CONDUCTING  
21 FORENSIC EXAMINATIONS OF VICTIMS OF SEXUAL ASSAULT.

22 (C) THE GOVERNOR'S OFFICE OF CRIME PREVENTION, YOUTH, AND  
23 VICTIM SERVICES SHALL ESTABLISH:

24 (1) AN APPLICATION PROCESS FOR NONPROFIT ENTITIES AND  
25 HIGHER EDUCATION INSTITUTIONS AND COLLEGES IN THE STATE TO APPLY FOR  
26 GRANT FUNDING FROM THE PROGRAM; AND

27 (2) ELIGIBILITY CRITERIA FOR SELECTING RECIPIENTS FOR GRANT  
28 FUNDING FROM THE PROGRAM.

30 (A) IN THIS SECTION, "FUND" MEANS THE FORENSIC NURSE EXAMINER  
31 TRAINING GRANT PROGRAM FUND.

1 (B) THERE IS A FORENSIC NURSE EXAMINER TRAINING GRANT PROGRAM

3 (C) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING FOR GRANTS  
4 AWARDED UNDER THE PROGRAM.

5 (D) THE GOVERNOR'S OFFICE OF CRIME PREVENTION, YOUTH, AND  
6 VICTIM SERVICES SHALL ADMINISTER THE FUND.

7 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT  
8 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

9 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,  
10 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

11 (F) THE FUND CONSISTS OF:

12 (1) REVENUE DISTRIBUTED TO THE FUND UNDER § 14-4602 OF THIS  
13 SUBTITLE; AND

14 (2) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR  
15 THE BENEFIT OF THE FUND.

16 (G) THE FUND MAY BE USED ONLY TO FUND GRANTS TO NONPROFIT  
17 ENTITIES THROUGH THE PROGRAM.

18 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND  
19 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

20 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO  
21 THE GENERAL FUND OF THE STATE.

22 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE  
23 WITH THE STATE BUDGET.

(A) IN THIS SECTION, "SEXUALLY ASSAULTIVE BEHAVIOR" HAS THE MEANING STATED IN § 10-923 OF THIS SUBTITLE.

(B) ~~EVIDENCE~~ INFORMATION THAT PHYSICAL EVIDENCE OF ~~A SEXUAL CRIME~~ SEXUALLY ASSAULTIVE BEHAVIOR WAS OBTAINED USING MATERIALS THAT WERE SOLD, OFFERED FOR SALE, OR DISTRIBUTED IN A MANNER THAT WOULD CONSTITUTE A VIOLATION OF § 14-4602 OF THE COMMERCIAL LAW ARTICLE IS NOT ADMISSIBLE IN A CRIMINAL OR CIVIL PROCEEDING INVOLVING AN ALLEGATION OF ~~A SEXUAL CRIME~~ SEXUALLY ASSAULTIVE BEHAVIOR.

(C) THIS SECTION MAY NOT BE CONSTRUED TO REQUIRE A COURT TO ADMIT PHYSICAL EVIDENCE.

#### Article – Criminal Procedure

11-926.

(J) (1) ANY AGREEMENT, CONDITION OF ACCESS OR USE, OR POLICY THAT LIMITS OR WAIVES ANY SUBSTANTIVE OR PROCEDURAL RIGHT OR REMEDY TO A CLAIM AGAINST ANY PERSON WHO PROVIDES A VICTIM OR ANOTHER PERSON WITH ANY SERVICE, PRODUCT, INFORMATION, OR OTHER MEANS TO COLLECT EVIDENCE OF A SEXUAL ASSAULT IS NULL AND VOID AS BEING AGAINST THE PUBLIC POLICY OF THE STATE.

(2) ANY DISCLAIMER OF ANY WARRANTIES, EXPRESS OR IMPLIED, OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NONINFRINGEMENT REGARDING ANY SERVICE, PRODUCT, INFORMATION, OR OTHER MEANS TO COLLECT EVIDENCE OF A SEXUAL ASSAULT IS NULL AND VOID AS BEING AGAINST THE PUBLIC POLICY OF THE STATE.

~~(j)~~ (K) The Attorney General shall adopt regulations for uniform statewide implementation of this section.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act ~~shall take effect October 1, 2024~~ is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
