County Boards of Education – Budgets – Notice (Transparency in Education Spending Act)

4 FOR the purpose of requiring the State Board of Education to adopt a process for the $\mathbf{5}$ uniform and timely reporting of certain county board of education budget 6 information to a county governing body; requiring a county board to post certain 7 information in a certain manner on the county board's website; requiring a certain 8 transfer to be made only following the approval of the county commissioners or the 9 county council; providing for exemptions from certain requirements related to 10 certain transfers; requiring a certain audit to be sent to the county council or the 11 county commissioners; and generally relating to the budgets of county boards of 12 education.
