Landlord and Tenant – Failure to Repair Serious and Dangerous Defects – Tenant Remedies (Tenant Safety Act of 2024)

- $\mathbf{5}$ FOR the purpose of establishing that a landlord that offers a dwelling for rent is deemed to 6 warrant the dwelling fit for human habitation; clarifying that certain mold hazards 7 constitute dangerous conditions and defects for which a tenant may obtain relief; 8 authorizing multiple tenants to join as plaintiffs in the same civil action against a 9 landlord; establishing that, prior to a certain court order, there is a rebuttable presumption that a tenant is entitled to have a court adjudicate a request for rent 10 11 abatement; establishing a rebuttable presumption related to the abatement of 12prospective rent and the requirements for rent escrow; establishing a rebuttable 13 presumption that limits rent escrow payments to rent that is due and unpaid 14 subsequent to a court order; authorizing the award of attorney's fees, costs, and 15expenses related to litigation and a tenant who prevails in certain actions; 16establishing that certain local laws preempt certain provisions of this Act; 17authorizing certain remedies for a tenant if a landlord breaches the warranty of 18 habitability; providing that a landlord may raise certain defenses in a civil action 19related to the breach of the warranty of habitability; providing that a court may order 20certain relief in civil actions related to the breach of the warranty of habitability, 21including actual damages, abatement of rent due and unpaid, and the termination 22of a lease; and generally relating to remedies for a landlord's failure to repair serious 23and dangerous defects.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
6 That the Laws of Maryland read as follows:

Article – Real Property

8 8-211.

9 (a) (1) The purpose of this section is to provide tenants with a mechanism for 10 encouraging the repair of serious and dangerous defects which exist within or as part of 11 any residential dwelling unit, or [upon the] ON property used in common of which the 12 dwelling unit forms a part.

13 (2) The defects sought to be reached by this section are those which present 14 a substantial and serious threat of danger to the life, health, and safety of the occupants of 15 the dwelling unit, and not those which merely impair the aesthetic value of the premises, 16 or which are, in those locations governed by such codes, housing code violations of a 17 nondangerous nature.

18 (3) The intent of this section is not to provide a remedy for dangerous 19 conditions in the community at large which exists apart from the leased premises or the 20 property in common of which the leased premises forms a part.

(b) It is the public policy of [Maryland] THE STATE that meaningful sanctions be imposed [upon those who allow] ON A LANDLORD THAT ALLOWS dangerous conditions and defects to exist in leased premises, and that an effective mechanism be established for repairing these conditions and halting their creation.

25 (c) (1) [This] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS 26 SUBSECTION, THIS section applies to ALL residential dwelling units leased for the purpose 27 of human habitation within the State [of Maryland. This section does not apply to farm 28 tenancies.

29 (d) This section applies to all applicable dwelling units] whether they are [(1) 30 publicly]:

- 31 (I) **PUBLICLY** or privately owned; or [(2) single]
- 32 (II) SINGLE or multiple units.
- 33 (2) THIS SECTION DOES NOT APPLY TO FARM TENANCIES.

7 (l) It is a sufficient defense to the allegations of the tenant that the tenant, the 8 tenant's family, agent, employees, or assignees or social guests have caused the asserted 9 defects or conditions, or that the landlord or the landlord's agents were denied reasonable 10 and appropriate entry for the purpose of correcting or repairing the asserted conditions or 11 defects.

12 (m) The court shall make appropriate findings of fact and make any order that the 13 justice of the case may require, including any one or a combination of the following:

14 (1) Order the termination of the lease and return of the leased premises to 15 the landlord, subject to the tenant's right of redemption;

- (2) Order that the action for rent escrow be dismissed;

17 (3) Order that the amount of rent required by the lease, whether paid into 18 court or to the landlord, be abated and reduced in an amount determined by the court to be 19 fair and equitable to represent the existence of the conditions or defects found by the court 20 to exist; or

(4) Order the landlord to make the repairs or correct the conditionscomplained of by the tenant and found by the court to exist.

23 (n) (1) After rent escrow has been established, the court:

[(1)] (I) Shall, after a hearing, if so ordered by the court or one is requested by the landlord, order that the money in the escrow account be disbursed to the landlord after the necessary repairs have been made;

[(2)] (II) May, after an appropriate hearing, order that some or all money in the escrow account be paid to the landlord or the landlord's agent, the tenant or the tenant's agent, or any other appropriate person or agency for the purpose of making the necessary repairs of the dangerous conditions or defects;

[(3)] (III) May, after a hearing if one is requested by the landlord, appoint a special administrator who shall cause the repairs to be made, and who shall apply to the court to pay for them out of the money in the escrow account;

1 [(4)] (IV) May, after an appropriate hearing, order that some or all money 2 in the escrow account be disbursed to pay any mortgage or deed of trust on the property in 3 order to stay a foreclosure;

[(5)] (V) May, after a hearing, if one is requested by the tenant, order, if no repairs are made or if no good faith effort to repair is made within [six] 6 months of the initial decision to place money in the escrow account, that the money in the escrow account be disbursed to the tenant THAT HAVE PAID INTO ESCROW[. Such an order will not discharge the right on the part of the tenant to pay rent into court and an appeal will stay the forfeiture]; or

10 [(6)] (VI) May, after an appropriate hearing, order that the money in the 11 escrow account be disbursed to the landlord if the tenant does not regularly pay, into that 12 account, the rent owed.

28 (F) IT IS A DEFENSE TO A CLAIM UNDER THIS SECTION THAT:

(1) THE TENANT, THE TENANT'S FAMILY, AGENT, EMPLOYEES,
 ASSIGNEES, OR SOCIAL GUESTS CAUSED THE ASSERTED DEFECTS OR CONDITIONS;
 OR

1 (2) THE LANDLORD OR THE LANDLORD'S AGENTS WERE DENIED 2 REASONABLE AND APPROPRIATE ENTRY FOR THE PURPOSE OF CORRECTING OR 3 REPAIRING THE ASSERTED CONDITIONS OR DEFECTS.

4 (G) THE COURT SHALL MAKE APPROPRIATE FINDINGS OF FACT AND ISSUE 5 ANY ORDER THAT THE JUSTICE OF THE CASE MAY REQUIRE, INCLUDING ORDERING 6 ANY OF THE FOLLOWING:

- 7 (1) AN AWARD OF ACTUAL DAMAGES;
- 8 (2) AN ABATEMENT OF RENT DUE AND UNPAID; OR

9 (3) THE TERMINATION OF THE LEASE, RETURN OF ANY UNUSED 10 PORTION OF A SECURITY DEPOSIT TO THE TENANT, AND RELOCATION EXPENSES 11 FOR A TENANT.

12 (H) IF A COURT ORDERS ANY RELIEF TO A TENANT UNDER THIS SECTION, 13 THE TENANT MAY RECOVER REASONABLE:

14 (1) ATTORNEY'S FEES AND COSTS; AND

15(2)EXPENSES RELATED TO LITIGATION, SUCH AS EXPENSES FOR A16MOLD ASSESSMENT AT THE RESIDENCE OF THE TENANT.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2024.
