Wildlife - Protections and Highway Crossings

3 FOR the purpose of requiring the Department of Natural Resources, in collaboration with 4 the State Highway Administration, to identify and prioritize certain species whose 5 habitat or movement corridors intersect with State highways and develop tools, 6 technology, and techniques to identify certain State highway infrastructure 7 locations; requiring the Department of Natural Resources to take certain actions 8 regarding a statewide deer population survey on or before certain dates; requiring 9 the Department of Transportation to update certain design guidance to incorporate 10 certain design concepts on or before a certain date; requiring the State Highway 11 Administration to consult with the Department of Natural Resources on the design 12 of certain bridges, culverts, and State highways; establishing certain requirements 13 for the construction of certain bridges, culverts, and State highways; requiring the 14 State Highway Administration to consult with the Department of Natural Resources 15 regarding the replacement or renovation of certain bridges and culverts; establishing 16 the Wildlife Highway Crossings Fund as a special, nonlapsing fund; requiring 17 interest earnings of the Fund to be credited to the Fund; requiring the Secretary of 18 Natural Resources and the Secretary of Transportation to each designate an 19 interagency liaison officer to coordinate certain activities; requiring the State 20 Highway Administration to identify and apply for certain funding; requiring each 21 automobile insurance provider to charge a certain fee; requiring the Department of 22 Transportation to develop a process for each automobile insurance provider to remit 23 the fee to the Fund; and generally relating to wildlife protection.
