1 AN ACT concerning

2 **Hospitals and Related Institutions – Residential Treatment Centers –**
3 **Accreditation**

4 FOR the purpose of altering the definition of “accredited residential treatment center” for
5 certain provisions of law governing hospitals and related institutions to include
6 residential treatment centers accredited by the Commission on Accreditation of
7 Rehabilitation Facilities or the Council on Accreditation; and generally relating to
8 residential treatment centers.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Health – General**

2 (a) In this subtitle the following words have the meanings indicated.

3 (b) “Accredited hospital” means a hospital accredited by the Joint Commission on
4 Accreditation of Healthcare Organizations.

5 (c) “Accredited residential treatment center” means a residential treatment
6 center that is accredited by [the]:

7 (1) **THE** Joint Commission on Accreditation of Healthcare Organizations;

8 (2) **THE COMMISSION ON ACCREDITATION OF REHABILITATION**
9 **FACILITIES; OR**

10 (3) **THE COUNCIL ON ACCREDITATION.**

11 (j) “Nonaccredited residential treatment center” means a residential treatment
12 center that is not accredited by [the]:

13 (1) **THE** Joint Commission on Accreditation of Healthcare Organizations;

14 (2) **THE COMMISSION ON ACCREDITATION OF REHABILITATION**
15 **FACILITIES; OR**

16 (3) **THE COUNCIL ON ACCREDITATION.**

18 (a) This section applies to:

19 (1) Nonaccredited hospitals found in violation of the standards adopted
20 under this subtitle;

21 (2) Accredited hospitals:

22 (i) Found deficient as a result of the complaint review process; or

23 (ii) Subject to inspection by the Department under § 19–2302(e) of
24 this title as a result of a serious or life–threatening patient care deficiency identified by the
25 Joint Commission on Accreditation of Healthcare Organizations, the Centers for Medicare
26 and Medicaid Services, or the Department;

27 (3) Accredited residential treatment centers subject to inspection by the
28 Department under § 19–2302(e) of this title as a result of a serious or life–threatening

1 patient care deficiency identified by the Joint Commission on Accreditation of Healthcare
2 Organizations, **THE COMMISSION ON ACCREDITATION OF REHABILITATION**
3 **FACILITIES, THE COUNCIL ON ACCREDITATION**, the Centers for Medicare and
4 Medicaid Services, or the Department; and

5 (4) Health care facilities that fail to achieve substantial compliance with
6 the standards of an approved accreditation organization under § 19–2302(c)(2) of this title.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2024.
