1 AN ACT concerning

2 **Corrections – Segregated Housing – Limitations**

3 FOR the purpose of altering a reporting requirement for correctional units relating to
4 restrictive housing; requiring hearing officers and personnel involved in the
5 supervision and care of individuals placed in restrictive housing to undergo certain
6 training; establishing guidelines and procedures for the placement of incarcerated
7 individuals in certain types of segregated housing; and generally relating to
8 segregated housing.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Correctional Services**

23 9–614.

1 (a) (1) In this section the following words have the meanings indicated.

2 (2) **“ADMINISTRATIVE SEGREGATION” MEANS A NONPUNITIVE FORM**
3 **OF PHYSICAL SEPARATION OF AN INCARCERATED INDIVIDUAL FROM THE GENERAL**
4 **POPULATION OF A CORRECTIONAL FACILITY FOR A PERIOD OF 17 HOURS OR LESS**
5 **OUT OF A 24-HOUR PERIOD.**

6 (3) “Correctional unit” has the meaning stated in § 2-401 of this article.

7 (4) **“DISCIPLINARY SEGREGATION” MEANS A PUNITIVE FORM OF**
8 **PHYSICAL SEPARATION OF AN INCARCERATED INDIVIDUAL FROM THE GENERAL**
9 **POPULATION OF A CORRECTIONAL FACILITY FOR A PERIOD OF 17 HOURS OR LESS**
10 **OUT OF A 24-HOUR PERIOD.**

11 (5) **“RESIDENTIAL REHABILITATION UNIT” MEANS SEPARATE**
12 **HOUSING USED FOR THERAPY, TREATMENT, AND REHABILITATIVE PROGRAMMING:**

13 (I) **AS AN ALTERNATIVE TO RESTRICTIVE HOUSING FOR AN**
14 **INCARCERATED INDIVIDUAL; OR**

15 (II) **FOR AN INCARCERATED INDIVIDUAL WHO REQUIRES**
16 **SEPARATE HOUSING FOLLOWING PLACEMENT IN RESTRICTIVE HOUSING.**

17 [(3) (i)] (6) “Restrictive housing” means [a] ANY form of physical
18 separation [that has not been requested by the incarcerated individual] in which [the] AN
19 incarcerated individual is placed in a locked room or cell for [approximately 22 hours or
20 more] **MORE THAN 17 HOURS** out of a 24-hour period.

21 [(ii) “Restrictive housing” includes administrative segregation and
22 disciplinary segregation.]

23 (7) **“SERIOUS MENTAL ILLNESS” HAS THE MEANING STATED IN §**
24 **10-1003 OF THIS ARTICLE.**

25 (b) (1) On or before December 31 each year, each correctional unit shall submit
26 data **FOR THE PRECEDING YEAR** to the Governor’s Office of Crime Prevention, Youth, and
27 Victim Services showing, by correctional unit **AND DISAGGREGATED BY AGE, RACE,**
28 **GENDER, CLASSIFICATION OF HOUSING, AND BASIS FOR PLACEMENT:**

29 (i) the total population of the correctional unit;

30 (ii) the number of incarcerated individuals who have been placed in:

31 1. restrictive housing [during the preceding year by age,

1 race, gender, classification of housing, and the basis for the incarcerated individual's
2 placement in restrictive housing];

3 **2. ADMINISTRATIVE SEGREGATION; AND**

4 **3. DISCIPLINARY SEGREGATION;**

5 (iii) the number of incarcerated individuals with serious mental
6 illness that were placed in:

7 1. restrictive housing [during the preceding year];

8 **2. ADMINISTRATIVE SEGREGATION; AND**

9 **3. DISCIPLINARY SEGREGATION;**

10 (iv) [the definition of "serious mental illness" used by the correctional
11 unit in making the report;

12 (v)] the number of incarcerated individuals known to be pregnant
13 when placed in:

14 1. restrictive housing [during the preceding year];

15 **2. ADMINISTRATIVE SEGREGATION; AND**

16 **3. DISCIPLINARY SEGREGATION;**

17 [(vi)] (v) the average and median lengths of stay in:

18 1. restrictive housing [of the incarcerated individuals placed
19 in restrictive housing during the preceding year];

20 **2. ADMINISTRATIVE SEGREGATION; AND**

21 **3. DISCIPLINARY SEGREGATION;**

22 [(vii)] (vi) the number of incidents of death, self-harm, and attempts
23 at self-harm by incarcerated individuals in:

24 1. restrictive housing [during the preceding year];

25 **2. ADMINISTRATIVE SEGREGATION; AND**

1 INCARCERATED INDIVIDUAL PLACED IN RESTRICTIVE HOUSING, STRATEGIES
2 DESIGNED TO RETURN THE INDIVIDUAL TO THE GENERAL POPULATION IN THE
3 LEAST AMOUNT OF TIME;

4 5. AMEND POLICIES TO SPECIFY THAT RESTRICTIVE
5 HOUSING IS A SANCTION OF LAST RESORT; AND

6 6. ADOPT THE USE OF RESIDENTIAL REHABILITATION
7 UNITS;

8 [(ix)] (X) any other data the correctional unit considers relevant to
9 the use of restrictive housing, ADMINISTRATIVE SEGREGATION, AND DISCIPLINARY
10 SEGREGATION by correctional facilities in the State; and

11 [(x)] (XI) any changes to written policies or procedures at each
12 correctional unit relating to the use and conditions of restrictive housing, [including steps
13 to reduce reliance on restrictive housing] ADMINISTRATIVE SEGREGATION, AND
14 DISCIPLINARY SEGREGATION.

15 (2) The Governor's Office of Crime Prevention, Youth, and Victim Services
16 shall make the information submitted in accordance with paragraph (1) of this subsection
17 available on its website and, when the information has been received from every
18 correctional unit in accordance with paragraph (1) of this subsection, promptly submit the
19 information in a report to the General Assembly, in accordance with § 2-1257 of the State
20 Government Article.

22 **10-1001.**

23 **IN THIS SUBTITLE, "RESTRICTIVE HOUSING" HAS THE MEANING STATED IN §**
24 **9-614 OF THIS ARTICLE.**

25 **10-1002.**

26 **(A) (1) ALL PERSONNEL INVOLVED IN THE SUPERVISION AND CARE OF**
27 **INDIVIDUALS PLACED IN RESTRICTIVE HOUSING SHALL:**

28 **(I) COMPLETE AT LEAST 16 HOURS OF TRAINING, INCLUDING**
29 **TRAINING ON TRAUMA-INFORMED CARE, BEFORE BEING ASSIGNED TO A**
30 **RESTRICTIVE HOUSING UNIT; AND**

31 **(II) RECEIVE AT LEAST 4 HOURS OF ADDITIONAL TRAINING**
32 **ANNUALLY.**

1 **(2) A HEARING OFFICER SHALL:**

2 **(I) COMPLETE AT LEAST 8 HOURS OF TRAINING, INCLUDING**
3 **TRAINING ON TRAUMA-INFORMED CARE, THE PHYSICAL AND PSYCHOLOGICAL**
4 **EFFECTS OF RESTRICTIVE HOUSING, PROCEDURAL AND DUE PROCESS RIGHTS OF**
5 **INCARCERATED INDIVIDUALS, AND RESTORATIVE JUSTICE REMEDIES, PRIOR TO**
6 **PRESIDING OVER ANY HEARINGS; AND**

7 **(II) RECEIVE AT LEAST 4 HOURS OF ADDITIONAL TRAINING**
8 **ANNUALLY.**

9 **(B) NOTHING IN THIS SECTION SHALL BE CONSTRUED TO LIMIT OVERTIME**
10 **COMPENSATION FOR PERSONNEL AND HEARING OFFICERS REQUIRED TO ATTEND**
11 **TRAINING UNDER THIS SECTION.**

12 **10-1003.**

13 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
14 **INDICATED.**

15 **(2) "SERIOUS MENTAL ILLNESS" MEANS A MENTAL DISORDER THAT:**

16 **(I) IS DIAGNOSED, ACCORDING TO A CURRENT DIAGNOSTIC**
17 **CLASSIFICATION SYSTEM RECOGNIZED BY THE SECRETARY, AS:**

18 1. **SCHIZOPHRENIC DISORDER;**

19 2. **MAJOR AFFECTIVE DISORDER;**

20 3. **ANOTHER PSYCHOTIC DISORDER; OR**

21 4. **BORDERLINE OR SCHIZOTYPAL PERSONALITY**
22 **DISORDER, EXCLUDING AN ABNORMALITY THAT MANIFESTS ONLY AS REPEATED**
23 **CRIMINAL OR OTHERWISE ANTISOCIAL CONDUCT;**

24 **(II) IS CHARACTERIZED BY IMPAIRED FUNCTION ON A**
25 **CONTINUING OR INTERMITTENT BASIS FOR AT LEAST 2 YEARS; AND**

26 **(III) INCLUDES AT LEAST THREE OF THE FOLLOWING:**

27 1. **INABILITY TO MAINTAIN EMPLOYMENT;**

1 **2. SOCIAL BEHAVIOR THAT RESULTS IN INTERVENTIONS**
2 **BY THE MENTAL HEALTH SYSTEM;**

3 **3. SEVERE INABILITY TO ESTABLISH OR MAINTAIN A**
4 **PERSONAL SUPPORT SYSTEM; OR**

5 **4. NEED FOR ASSISTANCE WITH BASIC LIVING SKILLS.**

6 **(3) “VULNERABLE INDIVIDUAL” MEANS AN INDIVIDUAL WHO,**
7 **BECAUSE OF AGE, IDENTIFY, STATUS, DISABILITY, OR CIRCUMSTANCES, MAY BE**
8 **PARTICULARLY SUSCEPTIBLE TO CRIMINAL VICTIMIZATION AND MAY FACE SPECIAL**
9 **CHALLENGES IN INTERACTIONS WITH OTHER INCARCERATED INDIVIDUALS.**

10 **(B) SUBJECT TO SUBSECTION (G) OF THIS SECTION, A VULNERABLE**
11 **INDIVIDUAL MAY NOT BE PLACED IN RESTRICTIVE HOUSING UNLESS:**

12 **(1) THE VULNERABLE INDIVIDUAL IS BETWEEN AT LEAST 18 YEARS**
13 **OLD AND UNDER THE AGE OF 26 YEARS OR HAS A SERIOUS MENTAL ILLNESS; AND**

14 **(2) THE MANAGING OFFICIAL AND THE CHIEF PHYSICIAN OF THE**
15 **CORRECTIONAL FACILITY HAVE DETERMINED, AND RECORDED IN WRITING THE**
16 **REASONS FOR DETERMINING, THAT:**

17 **(I) THE INDIVIDUAL PRESENTS A GRAVE RISK OF HARM TO THE**
18 **INDIVIDUAL OR OTHERS; AND**

19 **(II) RESTRICTIVE HOUSING IS THE ONLY MEANS OF ENSURING**
20 **THE SAFETY OF THE INDIVIDUAL OR OTHERS FROM THE RISK OF HARM PRESENTED**
21 **BY THE INDIVIDUAL.**

22 **(C) AN INDIVIDUAL MAY NOT BE PLACED IN RESTRICTIVE HOUSING BASED**
23 **SOLELY ON:**

24 **(1) CONFIDENTIAL INFORMATION CONSIDERED BY THE FACILITY**
25 **STAFF, BUT NOT PROVIDED TO THE INCARCERATED INDIVIDUAL OR INCLUDED IN**
26 **REQUIRED RECORDS;**

27 **(2) GANG OR ENEMY AFFILIATION;**

28 **(3) PROTECTION OF THE INDIVIDUAL FROM THE REST OF THE**
29 **DETAINED POPULATION OR A LIKELY ABUSER; OR**

30 **(4) THE INCARCERATED INDIVIDUAL’S IDENTIFIED OR PERCEIVED**

1 SEXUAL ORIENTATION OR GENDER IDENTITY.

2 (D) THE MANAGING OFFICIAL OF A CORRECTIONAL FACILITY SHALL
3 ENSURE THAT EACH INCARCERATED INDIVIDUAL PLACED IN RESTRICTIVE HOUSING
4 IS PROVIDED THE FOLLOWING INFORMATION, IN A LANGUAGE OR MANNER THE
5 INDIVIDUAL CAN UNDERSTAND, WITHIN 24 HOURS OF THE INDIVIDUAL'S
6 PLACEMENT IN RESTRICTIVE HOUSING:

7 (1) NOTICE OF THE FACTS AND CIRCUMSTANCES THAT LED TO
8 PLACING THE INDIVIDUAL IN RESTRICTIVE HOUSING;

9 (2) A STATEMENT OF THE REASON OR REASONS WHY A LESS
10 RESTRICTIVE INTERVENTION WOULD BE INSUFFICIENT TO REDUCE RISK;

11 (3) THE PROCEDURES THAT THE FACILITY WILL EMPLOY TO MONITOR
12 THE INDIVIDUAL;

13 (4) THE DATE AND TIME OF THE INDIVIDUAL'S NEXT COURT DATE OR
14 ADMINISTRATIVE HEARING DATE, IF APPLICABLE;

15 (5) COPIES OF ALL DOCUMENTS, FILES, AND RECORDS RELATING TO
16 THE INDIVIDUAL'S PLACEMENT IN RESTRICTIVE HOUSING, UNLESS A DOCUMENT,
17 FILE, OR RECORD CONTAINS CONTRABAND, CLASSIFIED INFORMATION, OR
18 SENSITIVE SECURITY INFORMATION; AND

19 (6) AN EXPLANATION OF THE PROCESS TO APPEAL THE INITIAL
20 PLACEMENT OR CONTINUED PLACEMENT OF THE INCARCERATED INDIVIDUAL IN
21 RESTRICTIVE HOUSING UNDER SUBSECTION (E) OF THIS SECTION.

22 (E) (1) AN INCARCERATED INDIVIDUAL SHALL BE PROVIDED THE
23 OPPORTUNITY TO CONTEST THE RESTRICTIVE HOUSING PLACEMENT IN AN
24 ADMINISTRATIVE HEARING WITHIN 70 HOURS OF THE INITIAL PLACEMENT.

25 (2) THE INCARCERATED INDIVIDUAL SHALL HAVE THE RIGHT TO
26 APPEAR AND BE REPRESENTED BY AN ATTORNEY OR ADVOCATE OF THE
27 INDIVIDUAL'S CHOOSING AT THE INDIVIDUAL'S OWN EXPENSE AT ALL HEARINGS
28 CONDUCTED UNDER PARAGRAPH (1) OF THIS SUBSECTION.

29 (F) (1) IF AN INDIVIDUAL IN RESTRICTIVE HOUSING DISPUTES A
30 DECISION MADE REGARDING THE INDIVIDUAL'S STATUS AS A VULNERABLE
31 INDIVIDUAL OR THE PLACEMENT OF THE INDIVIDUAL IN RESTRICTIVE HOUSING
32 UNDER SUBSECTION (B) OF THIS SECTION, THE INDIVIDUAL MAY REQUEST AND
33 RECEIVE A SECONDARY REVIEW OF THE DETERMINATION BY THE MANAGING

1 OFFICIAL OR CHIEF PHYSICIAN, AS APPROPRIATE.

2 (2) AN INCARCERATED INDIVIDUAL MAY NOT BE PLACED OR
3 RETAINED IN RESTRICTIVE HOUSING IF, FOLLOWING A SECONDARY REVIEW UNDER
4 PARAGRAPH (1) OF THIS SUBSECTION, THE MANAGING OFFICIAL OR CHIEF
5 PHYSICIAN DETERMINES THAT THE INDIVIDUAL NO LONGER MEETS THE STANDARD
6 FOR CONFINEMENT.

7 (G) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,
8 AN INCARCERATED INDIVIDUAL MAY NOT BE SUBJECT TO RESTRICTIVE HOUSING
9 FOR MORE THAN:

10 (I) 3 CONSECUTIVE DAYS; OR

11 (II) 6 DAYS IN ANY 60-DAY PERIOD.

12 (2) (I) AN INCARCERATED INDIVIDUAL MAY BE PLACED IN
13 RESTRICTIVE HOUSING FOR A PERIOD OF TIME EXCEEDING A TIME PERIOD
14 SPECIFIED IN PARAGRAPH (1) OF THIS SUBSECTION IF THE COMMISSIONER OF
15 CORRECTION OR THE COMMISSIONER'S DESIGNEE ISSUES A WRITTEN DECISION,
16 FOLLOWING AN EVIDENTIARY HEARING, THAT STATES BASED ON SPECIFIC
17 OBJECTIVE CRITERIA THAT:

18 1. THE INCARCERATED INDIVIDUAL:

19 A. COMMITTED AN ACT CAUSING PHYSICAL INJURY TO
20 OR DEATH OF ANOTHER;

21 B. COMMITTED SEXUAL ASSAULT;

22 C. COMMITTED EXTORTION;

23 D. COERCED OR ATTEMPTED TO COERCE ANOTHER TO
24 VIOLATE RULES OF THE FACILITY;

25 E. LED OR INCITED A RIOT; OR

26 F. PROCURED DEADLY WEAPONS OR OTHER
27 CONTRABAND THAT POSE A SERIOUS THREAT TO SECURITY; AND

28 2. THE ACT WAS SO HEINOUS OR DESTRUCTIVE THAT
29 PLACEMENT IN THE GENERAL POPULATION WOULD CREATE A SIGNIFICANT RISK OF
30 IMMINENT SERIOUS PHYSICAL INJURY.

1 (II) IF THE COMMISSIONER OF CORRECTION OR THE
2 COMMISSIONER'S DESIGNEE MAKES THE FINDINGS AND ISSUES THE WRITTEN
3 DECISION REQUIRED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE
4 INCARCERATED INDIVIDUAL MAY NOT BE PLACED IN RESTRICTIVE HOUSING FOR
5 MORE THAN:

- 6 1. 15 CONSECUTIVE DAYS;
- 7 2. 18 DAYS IN ANY 60-DAY PERIOD; OR
- 8 3. 60 DAYS IN ANY 365-DAY PERIOD.

9 (H) (1) AN INCARCERATED INDIVIDUAL IN RESTRICTIVE HOUSING SHALL
10 BE GIVEN A PHYSICAL AND MENTAL HEALTH ASSESSMENT WITHIN AT LEAST 24
11 HOURS OF THE INITIAL PLACEMENT IN RESTRICTIVE HOUSING AND EVERY 24
12 HOURS THEREAFTER.

13 (2) THE PHYSICAL AND MENTAL HEALTH ASSESSMENT SHALL BE
14 PERFORMED BY:

- 15 (I) AT LEAST ONE LICENSED MENTAL HEALTH PROFESSIONAL;
- 16 (II) AT LEAST ONE MEDICAL PROFESSIONAL; AND
- 17 (III) AT LEAST ONE MEMBER OF THE MANAGEMENT OF THE
18 FACILITY.

19 (3) AN INCARCERATED INDIVIDUAL IN RESTRICTIVE HOUSING SHALL
20 HAVE ACCESS TO:

- 21 (I) EDUCATIONAL AND READING MATERIALS;
- 22 (II) ONLINE EDUCATIONAL PROGRAMMING THAT THE
23 INDIVIDUAL WAS ENROLLED IN PRIOR TO BEING PLACED IN RESTRICTIVE HOUSING;
24 AND
- 25 (III) CASE MANAGEMENT, CLERGY, AND MENTAL HEALTH
26 PROFESSIONALS.

27 (4) AN INCARCERATED INDIVIDUAL IN RESTRICTIVE HOUSING MAY
28 NOT BE SUBJECT TO IMPOSITION OF ANY CHANGE IN DIET AS A FORM OF
29 PUNISHMENT.

1 **(5) (I) AN INCARCERATED INDIVIDUAL IN RESTRICTIVE HOUSING**
2 **SHALL BE OFFERED AT LEAST 4 HOURS OF OUT-OF-CELL PROGRAMMING PER DAY,**
3 **INCLUDING:**

4 **1. AT LEAST 1 HOUR FOR RECREATION; AND**

5 **2. AT LEAST 1 HOUR FOR SHOWERING, USE OF A**
6 **TELEPHONE, OR CONTACT VISITATION.**

7 **(II) TIME SPENT ON HOUSEKEEPING OR IN PAID EMPLOYMENT**
8 **MAY NOT BE CONSIDERED OUT-OF-CELL PROGRAMMING.**

9 **(I) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**
10 **FACILITY SHALL CONDUCT AN EXTERNAL VISUAL CHECK ON AN INDIVIDUAL PLACED**
11 **IN RESTRICTIVE HOUSING AT LEAST TWICE PER SHIFT.**

12 **(2) IF AN INDIVIDUAL PLACED IN RESTRICTIVE HOUSING**
13 **DEMONSTRATES BEHAVIOR THAT IS UNUSUAL, SUICIDAL, OR INDICATES A**
14 **LIKELIHOOD OF SELF-HARM, THE FACILITY STAFF SHALL MONITOR THE**
15 **INDIVIDUAL AT LEAST EVERY 15 MINUTES, OR MORE FREQUENTLY IF**
16 **RECOMMENDED BY A MEDICAL OR MENTAL HEALTH PROFESSIONAL.**

17 **(J) RESTRAINTS MAY NOT BE USED ON AN INCARCERATED INDIVIDUAL**
18 **PLACED IN RESTRICTIVE HOUSING, IN THE PROCESS OF BEING PLACED IN OR**
19 **RELEASED FROM RESTRICTIVE HOUSING, OR BEING MOVED OR TRANSPORTED TO**
20 **OR FROM RESTRICTIVE HOUSING FOR THE PURPOSES OF RECREATION, PROGRAMS,**
21 **OR OTHER SERVICES, UNLESS THE FACILITY HAS DOCUMENTED THAT RESTRAINTS**
22 **ARE REQUIRED BECAUSE OF HIGH RISK OF PHYSICAL HARM TO THE INDIVIDUAL OR**
23 **OTHERS.**

24 **(K) (1) AN INCARCERATED INDIVIDUAL MAY BE PLACED IN SEGREGATED**
25 **HOUSING FOR MEDICAL PURPOSES, ONLY IF:**

26 **(I) THE INDIVIDUAL IS KEPT IN THE SEGREGATED HOUSING**
27 **FOR THE SHORTEST AMOUNT OF TIME REQUIRED TO REDUCE THE RISK OF**
28 **INFECTION;**

29 **(II) THE PLACEMENT IS IN ACCORDANCE WITH STATE AND**
30 **FEDERAL PUBLIC HEALTH GUIDANCE; AND**

31 **(III) A LICENSED PHYSICIAN OR NURSE PRACTITIONER HAS**
32 **PROVIDED WRITTEN APPROVAL OF THE PLACEMENT.**

1 **(2) AN INCARCERATED INDIVIDUAL PLACED IN SEGREGATED**
2 **HOUSING FOR MEDICAL PURPOSES SHALL BE ALLOWED TO PARTICIPATE IN**
3 **PROGRAMS AND SERVICES, SUBJECT TO CONSIDERATIONS OF THE HEALTH AND**
4 **SECURITY OF THE INDIVIDUAL, OTHER INCARCERATED INDIVIDUALS, FACILITY**
5 **STAFF, VISITORS, AND THE PUBLIC.**

6 **(L) (1) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, IF**
7 **AN INCARCERATED INDIVIDUAL NOTIFIES THE STAFF OF THE CORRECTIONAL**
8 **FACILITY THAT THE INDIVIDUAL FEARS FOR THE INDIVIDUAL'S SAFETY AND**
9 **REQUESTS AN ACCOMMODATION TO FACILITATE THE INDIVIDUAL'S SAFETY, THE**
10 **FACILITY SHALL TRANSFER THE INDIVIDUAL, WITHIN A REASONABLE AMOUNT OF**
11 **TIME, BUT NOT LONGER THAN 3 DAYS, AFTER RECEIVING THE REQUEST TO AN**
12 **APPROPRIATE ACCOMMODATION, INCLUDING TRANSFER TO:**

13 **1. A SINGLE CELL;**

14 **2. A DIFFERENT SECTION OF THE FACILITY;**

15 **3. A SENSITIVE NEEDS YARD; OR**

16 **4. IF THE MANAGING OFFICIAL OF THE CORRECTIONAL**
17 **FACILITY DETERMINES THAT AN ACCOMMODATION IN ITEMS 1 THROUGH 3 OF THIS**
18 **SUBPARAGRAPH IS UNAVAILABLE OR CANNOT ADEQUATELY MEET THE SAFETY**
19 **NEEDS OF THE INDIVIDUAL, ANOTHER CORRECTIONAL FACILITY THAT CAN MEET**
20 **THE SAFETY NEEDS OF THE INDIVIDUAL.**

21 **(II) RESTRICTIVE HOUSING IS NOT AN APPROPRIATE**
22 **ACCOMMODATION FOR AN INDIVIDUAL WHO MAKES A REQUEST UNDER THIS**
23 **PARAGRAPH.**

24 **(2) AN INDIVIDUAL PLACED IN AN ACCOMMODATION UNDER**
25 **PARAGRAPH (1) OF THIS SUBSECTION SHALL BE GRANTED FULL ACCESS TO**
26 **OUT-OF-CELL TIME, PROGRAMMING, AND OTHER SERVICES AVAILABLE TO THE**
27 **REST OF THE DETAINED POPULATION.**

28 **(3) PLACEMENT OF AN INCARCERATED INDIVIDUAL IN AN**
29 **ACCOMMODATION UNDER THIS SUBSECTION MAY NOT BE NOTED IN THE**
30 **INCARCERATED INDIVIDUAL'S BASE FILE OR INSTITUTIONAL RECORD IF THE**
31 **NOTATION WOULD SERVE TO INTERRUPT THE INDIVIDUAL'S PROGRAMMING**
32 **ELIGIBILITY, PAROLE CONSIDERATIONS, SECURITY STATUS CHANGES, OR OTHER**
33 **OPPORTUNITIES.**

1 **(4) (I) AN INCARCERATED INDIVIDUAL WHO HAS BEEN PLACED IN**
2 **AN ACCOMMODATION THAT ISOLATES THE INDIVIDUAL FROM THE GENERAL**
3 **POPULATION OF THE CORRECTIONAL FACILITY UNDER THIS SUBSECTION MAY**
4 **SUBMIT A WRITTEN REQUEST TO THE FACILITY STAFF AT ANY TIME TO BE RETURNED**
5 **TO THE GENERAL POPULATION OF THE CORRECTIONAL FACILITY.**

6 **(II) AFTER RECEIVING A WRITTEN REQUEST UNDER THIS**
7 **PARAGRAPH, THE FACILITY STAFF SHALL PROMPTLY, BUT NOT LATER THAN 24**
8 **HOURS AFTER RECEIVING THE REQUEST, RETURN THE INCARCERATED INDIVIDUAL**
9 **TO THE GENERAL POPULATION OF THE CORRECTIONAL FACILITY.**

10 **(M) THE DECISION TO REMOVE ANY PERSONAL ITEMS OR CLOTHING FROM**
11 **AN INCARCERATED INDIVIDUAL PLACED IN RESTRICTIVE HOUSING SHALL BE:**

12 **(1) MADE BY THE MANAGING OFFICIAL OR DESIGNEE OF THE**
13 **MANAGING OFFICIAL BEFORE THE INCARCERATED INDIVIDUAL'S TRANSFER TO**
14 **RESTRICTIVE HOUSING OR AS SOON AS POSSIBLE AFTER THE TRANSFER; AND**

15 **(2) BASED ON A DETERMINATION THAT THE ITEM OR CLOTHING**
16 **POSES A SIGNIFICANT AND UNREASONABLE RISK OF HARM TO THE INDIVIDUAL OR**
17 **OTHERS.**

18 **(N) AN INCARCERATED INDIVIDUAL PLACED IN ADMINISTRATIVE**
19 **SEGREGATION OR DISCIPLINARY SEGREGATION SHALL HAVE THE SAME ACCESS TO**
20 **PROGRAMMING, WORK ASSIGNMENTS, RECREATIONAL ACTIVITIES, AND VISITATION**
21 **AS THE POPULATION OF THE CORRECTIONAL INSTITUTION THAT IS NOT**
22 **SEGREGATED.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2024.
