## 1 AN ACT concerning

# Occupational and Professional Licensing – Military Training and Military Spouses

#### 4 FOR the purpose of requiring an occupational licensing board to issue a license, certificate, $\mathbf{5}$ permit, or registration to an applicant who is military trained or who is a military 6 spouse if the applicant meets certain requirements; requiring an occupational 7 licensing board to consider certain types of experience for a certain calculation; 8 authorizing an occupational licensing board to issue a temporary license, certificate, 9 permit, or registration under certain circumstances; and generally relating to occupational and professional licenses, certificates, permits, and registrations for 10 11 military-trained individuals and military spouses.

### 12BY adding to 13Article – State Government Section 10–1701 and 10–1702 to be under the new subtitle "Subtitle 17. Occupational 14 15and Professional Licensing for Military Training and Military Spouses" 16 Annotated Code of Maryland 17(2021 Replacement Volume and 2023 Supplement) 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 19That the Laws of Maryland read as follows:

3 (B) "MILITARY SPOUSE" MEANS AN INDIVIDUAL WHOSE SPOUSE IS A 4 MEMBER OF THE UNITED STATES ARMED FORCES.

 $\mathbf{5}$ **"OCCUPATIONAL (C)** (1) LICENSING BOARD" MEANS Α UNIT 6 RESPONSIBLE FOR ISSUING AN OCCUPATIONAL OR PROFESSIONAL LICENSE, 7 CERTIFICATE, PERMIT, OR REGISTRATION THAT IS REQUIRED FOR AN INDIVIDUAL TO PRACTICE AN OCCUPATION OR A PROFESSION IN THE STATE, INCLUDING A UNIT 8 AUTHORIZED UNDER THE AGRICULTURE ARTICLE, THE BUSINESS REGULATION 9 ARTICLE, THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE, THE 10 ENVIRONMENT ARTICLE, THE HEALTH OCCUPATIONS ARTICLE, THE PUBLIC 11 SAFETY ARTICLE, OR THE TRANSPORTATION ARTICLE. 12

13 (2) "OCCUPATIONAL LICENSING BOARD" DOES NOT INCLUDE THE 14 STATE BOARD OF LAW EXAMINERS, AUTHORIZED UNDER TITLE 10 OF THE 15 BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.

17 (A) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AN OCCUPATIONAL 18 LICENSING BOARD SHALL ISSUE A LICENSE, CERTIFICATE, PERMIT, OR 19 REGISTRATION, AS APPROPRIATE, TO AN APPLICANT TO PRACTICE AN OCCUPATION 20 OR A PROFESSION IN THE STATE IF THE APPLICANT:

(1) (I) HAS COMPLETED A MILITARY PROGRAM OF TRAINING, BEEN
AWARDED A MILITARY OCCUPATIONAL SPECIALTY, AND PERFORMED THAT
SPECIALTY AT A LEVEL THAT IS SUBSTANTIALLY EQUIVALENT TO OR EXCEEDS THE
REQUIREMENTS OF THE OCCUPATIONAL LICENSING BOARD TO WHICH THE
APPLICANT HAS APPLIED;

(II) HAS ENGAGED IN THE ACTIVE PRACTICE OF THE
OCCUPATION OR PROFESSION FOR WHICH THE INDIVIDUAL IS SEEKING A LICENSE,
CERTIFICATE, PERMIT, OR REGISTRATION FOR AT LEAST 2 OF THE 5 YEARS
IMMEDIATELY PRECEDING THE DATE OF THE APPLICATION;

(III) HAS NOT COMMITTED ANY ACT IN ANY JURISDICTION THAT
 WOULD HAVE CONSTITUTED GROUNDS FOR DENIAL, SUSPENSION, OR REVOCATION
 OF THE LICENSE, CERTIFICATE, PERMIT, OR REGISTRATION IN THE STATE AT THE
 TIME THE ACT WAS COMMITTED; AND

1 (IV) PAYS ANY FEES REQUIRED BY THE OCCUPATIONAL 2 LICENSING BOARD; OR

3 **(2) (I)** 

### (I) IS A MILITARY SPOUSE;

4 (II) HOLDS A CURRENT LICENSE, CERTIFICATE, PERMIT, OR 5 REGISTRATION FROM ANOTHER JURISDICTION AND THAT JURISDICTION'S 6 REQUIREMENTS FOR THE LICENSE, CERTIFICATE, PERMIT, OR REGISTRATION ARE 7 SUBSTANTIALLY EQUIVALENT TO OR EXCEED THE REQUIREMENTS OF THE 8 OCCUPATIONAL LICENSING BOARD TO WHICH THE APPLICANT HAS APPLIED;

9 (III) CAN DEMONSTRATE COMPETENCY IN THE OCCUPATION OR 10 PROFESSION IN A METHOD DETERMINED BY THE OCCUPATIONAL LICENSING BOARD;

(IV) HAS NOT COMMITTED ANY ACT IN ANY JURISDICTION THAT
 WOULD HAVE CONSTITUTED GROUNDS FOR DENIAL, SUSPENSION, OR REVOCATION
 OF THE LICENSE, CERTIFICATE, PERMIT, OR REGISTRATION IN THE STATE AT THE
 TIME THE ACT WAS COMMITTED;

15 (V) IS IN GOOD STANDING WITH AND HAS NOT BEEN 16 DISCIPLINED BY THE UNIT FROM THE JURISDICTION IN WHICH THE APPLICANT 17 HOLDS A CURRENT LICENSE, CERTIFICATE, PERMIT, OR REGISTRATION; AND

18(VI) PAYS ANY FEES REQUIRED BY THE OCCUPATIONAL19LICENSING BOARD.

20**(B)** AN OCCUPATIONAL LICENSING SHALL BOARD **CONSIDER** FULL-TIME AND PART-TIME EXPERIENCE, BOTH PAID AND UNPAID, WHEN 2122CALCULATING YEARS OF EXPERIENCE UNDER SUBSECTION (A)(1)(II) OF THIS SECTION OR WHEN DEMONSTRATING COMPETENCY UNDER SUBSECTION (A)(2)(III) 2324OF THIS SECTION.

25**(C)** AN OCCUPATIONAL LICENSING BOARD MAY ISSUE A TEMPORARY 26LICENSE, CERTIFICATE, PERMIT, OR REGISTRATION TO AN APPLICANT WHO IS LICENSED, CERTIFIED, PERMITTED, OR REGISTERED IN ANOTHER JURISDICTION 27WHILE THE APPLICANT IS IN THE PROCESS OF SATISFYING THE REQUIREMENTS OF 2829THIS SECTION IF THE OTHER REQUIREMENTS TO OBTAIN A LICENSE, CERTIFICATE, PERMIT, OR REGISTRATION IN THAT JURISDICTION ARE SUBSTANTIALLY 30 31EQUIVALENT TO OR EXCEED THE REQUIREMENTS OF THE OCCUPATIONAL 32LICENSING BOARD TO WHICH THE APPLICANT HAS APPLIED.

(D) AN OCCUPATIONAL LICENSING BOARD SHALL ADOPT REGULATIONS
 34 NECESSARY TO CARRY OUT THE REQUIREMENTS OF THIS SECTION.

1 (E) THIS SECTION DOES NOT PROHIBIT AN APPLICANT WHO MEETS THE 2 REQUIREMENTS OF SUBSECTION (A) OF THIS SECTION FROM APPLYING FOR AN 3 OCCUPATIONAL OR PROFESSIONAL LICENSE, CERTIFICATE, PERMIT, OR 4 REGISTRATION UNDER ANY OTHER PROVISION OF LAW.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2024.
