A BILL ENTITLED

1 AN ACT concerning

2 **Corporate Income Tax – Rate Reduction**
3 **(Economic Competitiveness Act of 2024)**

4 FOR the purpose of altering, over a certain period of years, the State income tax rate on
5 the Maryland taxable income of corporations; and generally relating to the Maryland
6 corporate income tax.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Tax – General**

15 10–105.

16 (b) The State income tax rate for a [corporation is 8.25% of Maryland taxable
17 income] **CORPORATION’S MARYLAND TAXABLE INCOME IS:**

18 **(1) FOR A TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2023,**
19 **BUT BEFORE JANUARY 1, 2025, 8.25%;**

20 **(2) FOR A TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2024,**
21 **BUT BEFORE JANUARY 1, 2026, 7.75%;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.



1 **(3) FOR A TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2025,**
2 **BUT BEFORE JANUARY 1, 2027, 7.25%;**

3 **(4) FOR A TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2026,**
4 **BUT BEFORE JANUARY 1, 2028, 6.75%; AND**

5 **(5) FOR A TAXABLE YEAR BEGINNING AFTER DECEMBER 31, 2027,**
6 **6.25%.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
8 1, 2024.
