1 AN ACT concerning

2 **Cosmetologists – Esthetic Services – Definition**

3 FOR the purpose of altering the definition of “provide esthetic services” to include certain
4 services and to provide that it does not include the diagnosis of illness, disease, or
5 injury or performing ablation of the dermis or hypodermis; and generally relating to
6 the provision of esthetic services.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Business Occupations and Professions**

20 5–101.

1 (a) In this title the following words have the meanings indicated.

2 (o) **(1)** “Provide esthetic services” means to provide to an individual, for
3 compensation, the service of:

4 [(1)] **(I)** cleansing, exercising, **EXFOLIATING**, massaging, **COSMETIC**
5 **MICRONEEDLING**, stimulating, **TONING**, or performing any other similar procedure on
6 the skin or scalp by electrical, mechanical, or any other means;

7 [(2)] **(II)** applying to the face, **BODY, OR SCALP** an alcohol, cream, lotion,
8 astringent, or cosmetic preparation; or

9 [(3)] **(III)** removing superfluous hair by the use of [a depilatory, tweezers,
10 or wax] **ELECTRICAL, MECHANICAL, OR ANY ~~OTHER~~ MEANS OTHER THAN BY THE USE**
11 **OF A LASER LIGHT-BASED DEVICE.**

12 **(2) “PROVIDE ESTHETIC SERVICES” INCLUDES:**

13 **(I) ~~APPLYING MAKEUP;~~**

14 **~~(II)~~ APPLYING EYELASH EXTENSIONS;**

15 **~~(III)~~ (II) PERFORMING SUPERFICIAL EXFOLIATION**
16 **TREATMENTS OF THE EPIDERMIS USING PROFESSIONAL AND OTHER**
17 **COMMERCIALY AVAILABLE PRODUCTS OR DEVICES;**

18 **~~(IV)~~ (III) PERFORMING TREATMENTS FOR THE RELAXATION,**
19 **HYDRATION, CONTOURING, AND BEAUTIFICATION OF THE FACE, SKIN, BODY,**
20 **EYELASHES, OR EYEBROWS; AND**

21 **~~(V)~~ (IV) PERFORMING NONABLATIVE SKIN REJUVENATION.**

22 **(3) “PROVIDE ESTHETIC SERVICES” DOES NOT INCLUDE:**

23 **(I) THE DIAGNOSIS OF ILLNESS, DISEASE, OR INJURY; OR**

24 **(II) PERFORMING ABLATION OF THE DERMIS OR HYPODERMIS.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2024.
