# Labor and Employment – Noncompete and Conflict of Interest Clauses – Veterinary and Health Care Professionals

- FOR the purpose of applying to certain veterinary and health care professionals certain
  provisions of law stating that certain noncompete and conflict of interest provisions
  in certain employment contracts are null and void as being against the public policy
  of the State; applying this Act retroactively; and generally relating to noncompete
