2 3	(c) The Chair of the Workgroup shall be selected by the Governor from among the members of the Workgroup.
4	(d) The Maryland State Arts Council shall provide staff for the Workgroup.

19 20	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect Jul 1, 2024. It shall remain effective for a period of 1 year and 6 months and, at the end of

December 31, 2025, this Act, with no further action required by the General Assembly, shall

be abrogated and of no further force and effect.
