- 3 FOR the purpose of requiring certain county boards of education to consider the pursuit of 4 certain certificates, certifications, or apprenticeships as the equivalent of pursuing 5 postsecondary education and provide a method for certain individuals to authorize 6 the release of certain student information to certain apprenticeship sponsors and 7 employers; requiring each public high school to inform students of certain 8 employment and skills training opportunities in a certain manner; requiring a 9 county board to pay for a student to take an apprenticeship entrance exam or 10 industrial certification exam under certain circumstances; and generally relating to 11 career education and apprenticeships.

- 2 (A) IN THIS SECTION, "PLATFORM" MEANS A COLLEGE AND CAREER
- 3 READINESS SOFTWARE PROGRAM THAT HELPS SCHOOL SYSTEMS AND SCHOOLS
- 4 ALIGN STUDENT STRENGTHS AND INTERESTS TO POSTSECONDARY GOALS AND
- 5 CAREERS.
- 6 (B) A COUNTY BOARD THAT USES A PLATFORM SHALL:
- 7 (1) CONSIDER THE PURSUIT OF A VOCATIONAL CERTIFICATE, AN

- 6 (II) "APPRENTICESHIP ENTRANCE EXAM" MEANS THE 7 TRADE-SPECIFIC ASSESSMENT USED TO EVALUATE A STUDENT'S BASIC APTITUDE 8 BEFORE THE STUDENT BEGINS THE PRACTICAL AND TECHNICAL TRAINING PHASE 9 OF AN APPRENTICESHIP.
- 10 (III) "INDUSTRIAL **CERTIFICATION** EXAM" THE **MEANS ASSESSMENT** STUDENT'S 11 INDUSTRY-RECOGNIZED **THAT DOCUMENTS** A 12 PERFORMANCE AND ACHIEVEMENT OF INDUSTRY STANDARDS AND RESULTS IN THE RECEIPT OF A CERTIFICATE, A LICENSE, OR ANY OTHER CREDENTIAL. 13
- 14 (2) IF A COUNTY BOARD PAYS FOR ANY STUDENT TO TAKE AN
 15 ADVANCED PLACEMENT EXAMINATION, A PRELIMINARY SCHOLASTIC APTITUDE
 16 TEST/NATIONAL MERIT SCHOLARSHIP QUALIFYING TEST, OR A SCHOLASTIC
 17 APTITUDE TEST, THE COUNTY BOARD SHALL PAY FOR A STUDENT TO TAKE AN
 18 APPRENTICESHIP ENTRANCE EXAM OR INDUSTRIAL CERTIFICATION EXAM.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024.
