- 1 (c) A holder of a Class B-D-7 beer, wine, and liquor license may sell beer, wine, 2 and liquor:
- 3 (1) from 9 a.m. to 9 p.m. in the area bounded by Liberty Heights Avenue, 4 Northern Parkway, Druid Park Drive, and Wabash Avenue;
- 5 (2) from 9 a.m. to 9 p.m. along the south side of Frederick Avenue between 6 South Augusta Avenue and South Loudon Avenue;
- 7 (3) from 9 a.m. to 10 p.m. in the area specified in the Park Heights Master 8 Plan adopted by the City in 2006; and

- 1 (i) a Class B beer and light wine license;
- 2 (ii) a Class B beer, wine, and liquor license;
- 3 (iii) a Class B–D–7 beer, wine, and liquor license;
- 4 (iv) a Class C beer and light wine license; and
- 5 (v) a Class C beer, wine, and liquor license.
- 6 (2) For a license holder in an area bounded by Liberty Heights Avenue, 7 Northern Parkway, Druid Park Drive, and Wabash Avenue, the hours of sale:
- 8 (i) may not begin before 9 a.m. or end after 10 p.m.; and
- 9 (ii) may not be extended if they begin later than 9 a.m. or end before 10 10 p.m.
