14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

18	(a) A person is guilty of reckless driving if he drives a motor vehicle:
19	(1) In wanton or willful disregard for the safety of persons or property; or
20 21	(2) In a manner that indicates a wanton or willful disregard for the safety of persons or property.

PREPAY THE FINE.

- 1 A person is guilty of negligent driving if he drives a motor vehicle in a careless 2 or imprudent manner that endangers any property or the life or person of any individual. 3 EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A PERSON CHARGED WITH A VIOLATION OF THIS SECTION THAT CONTRIBUTES TO AN 4 ACCIDENT THAT RESULTS IN THE DEATH OF ANOTHER: 5 6 **(I)** MUST APPEAR IN COURT; AND 7 (II) MAY NOT PREPAY THE FINE. 8 **(2)** AFTER A COURT HAS ISSUED A WRIT SETTING THE DATE, TIME, 9 AND PLACE FOR THE PERSON TO APPEAR, THE COURT MAY, FOR GOOD CAUSE 10 SHOWN: 11 **(I)** WAIVE THE REQUIREMENT TO APPEAR IN COURT; AND 12 (II) ALLOW THE PERSON TO ENTER A PLEA OF GUILTY AND
- 14 **(D)** A person convicted of a violation of subsection (a) of this section is subject to a 15 fine not exceeding \$1,000.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
