AN ACT concerning
Transportation – <u>Major</u> Change in Bus Service – Impacts Report <u>Publication on</u> <u>Website</u>
FOR the purpose of requiring the Maryland Transit Administration, before announcing any reduction or cancellation of an existing bus route or line, to compile a report on the impacts of the proposed service reduction or cancellation; requiring the Administration to publish the report on its website at least a certain number of days before the required public hearing on the proposed service change <u>altering the</u> information that the Maryland Transit Administration is required to publish on its website before helding a public hearing on a major cervice change required to publish on its
<u>website before holding a public hearing on a major service change</u> ; requiring the Administration to distribute the report <u>a certain report on proposed major service</u> <u>changes</u> to certain officials and entities ; and generally relating to service reductions or cancellations of <u>major service changes for</u> existing bus routes.
