SENATE BILL 130

1 CRIME OF INDECENT EXPOSURE WHEN THE PERSON KNOWS OR REASONABLY 2 SHOULD KNOW THAT A MINOR IS PRESENT AND THE MINOR IS:

3 (1) AT LEAST 2 YEARS OLD; AND

4 (2) MORE THAN 4 YEARS YOUNGER THAN THE PERSON.

5 [(b)] (D) (1) A person [convicted of indecent exposure] WHO VIOLATES 6 SUBSECTION (B) OF THIS SECTION is guilty of a misdemeanor and ON CONVICTION is 7 subject to imprisonment not exceeding 3 years or a fine not exceeding \$1,000 or both.

8 (2) A PERSON WHO VIOLATES SUBSECTION (C) OF THIS SECTION IS 9 GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT 10 NOT EXCEEDING 5 YEARS OR A FINE NOT EXCEEDING \$10,000 OR BOTH.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 October 1, 2024.
