1 (2) After the 40th day, and before the 80th day, from the commencement of 2 each regular session of the General Assembly, the Senate shall consider each year's 3 appointees to the Board collectively to ensure adequate balance of membership.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to 5 apply only prospectively and applies only after the next vacancy occurs on the Board of 6 Regents of the University System of Maryland after the effective date of this Act.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 1, 2024.
