## A BILL ENTITLED

1 AN ACT concerning

2 **University System of Maryland – Board of Regents – Membership**

3 FOR the purpose of requiring that certain appointing officials in making appointments to  
4 the Board of Regents of the University System of Maryland ensure that one member  
5 of the Board is a graduate of a historically Black college or university in the State;  
6 and generally relating to the membership of the Board of Regents of the University  
7 System of Maryland.

8 BY repealing and reenacting, without amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 12–102.

22 (b) The government of the University System of Maryland is vested in the Board  
23 of Regents of the University System of Maryland.

1 (c) The Board of Regents consists of 21 members as follows:

2 (1) (i) Except as provided in item (ii) of this item, two members shall be  
3 full-time students in good academic standing at an institution under the jurisdiction of the  
4 Board; and

5 (ii) A student member who is in good academic standing at the  
6 University of Maryland Global Campus shall be exempt from the full-time student  
7 requirement in item (i) of this item;

8 (2) One member shall be the Secretary of Agriculture ex officio;

9 (3) One member shall be the Secretary of Commerce ex officio;

10 (4) One member shall be appointed by the President of the Senate;

11 (5) One member shall be appointed by the Speaker of the House; and

12 (6) The remaining members of the Board shall **[be]:**

13 **(I) BE residents of the State[, shall be];**

14 **(II) BE appointed from the general public[, and shall include]; AND**

15 **(III) INCLUDE THE FOLLOWING INDIVIDUALS:**

16 **[(i)] 1. One individual with a background in higher education**  
17 **administration;**

18 **[(ii)] 2. One individual with a background in finance; and**

19 **[(iii)] 3. One individual with a background in diversity and**  
20 **workplace inclusion.**

21 (d) In making appointments to the Board, the Governor, the President of the  
22 Senate, and the Speaker of the House shall **[consider]:**

23 **(1) ENSURE THAT ONE MEMBER OF THE BOARD IS A GRADUATE OF A**  
24 **HISTORICALLY BLACK COLLEGE OR UNIVERSITY IN THE STATE; AND**

25 **(2) CONSIDER representation from all parts of the State.**

26 (e) (1) Each member of the Board appointed under subsection (c)(1) and (6) of  
27 this section shall be appointed by the Governor, with the advice and consent of the Senate.

1                   (2) After the 40th day, and before the 80th day, from the commencement of  
2 each regular session of the General Assembly, the Senate shall consider each year's  
3 appointees to the Board collectively to ensure adequate balance of membership.

4                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to  
5 apply only prospectively and applies only after the next vacancy occurs on the Board of  
6 Regents of the University System of Maryland after the effective date of this Act.

7                   SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
8 1, 2024.
