A BILL ENTITLED

1 AN ACT concerning

2 **Public Health – Clean Indoor Air Act – Revisions**

3 FOR the purpose of prohibiting vaping in certain indoor areas and certain mass
4 transportation; requiring that certain signs be posted and maintained in a certain
5 manner in each indoor area open to the public and each public entrance to an indoor
6 area where smoking or vaping is prohibited under the Clean Indoor Air Act; and
7 generally relating to the Clean Indoor Air Act.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

25 That the Laws of Maryland read as follows:

2 24–501.

3 (a) In this subtitle the following words have the meanings indicated.

4 (b) “Cannabis” has the meaning stated in [§ 5–101 of the Criminal Law Article]
5 **§ 1–101 OF THE ALCOHOLIC BEVERAGES AND CANNABIS ARTICLE.**6 (c) **“ELECTRONIC SMOKING DEVICE” HAS THE MEANING STATED IN §**
7 **16.7–101 OF THE BUSINESS REGULATION ARTICLE.**8 [(c)] (D) “Employee” has the meaning stated in § 5–101 of the Labor and
9 Employment Article.10 [(d)] (E) “Employer” has the meaning stated in § 5–101 of the Labor and
11 Employment Article.

12 [(e)] (F) “Environmental smoke” means [the]:

13 (1) **THE** complex mixture formed from the escaping smoke of a burning
14 tobacco, cannabis, or hemp product or smoke exhaled by the smoker; **OR**15 (2) **THE COMPLEX MIXTURE FORMED FROM THE ESCAPING AEROSOL**
16 **OF AN ELECTRONIC SMOKING DEVICE OR EXHALED AS ELECTRONIC SMOKING**
17 **DEVICE AEROSOL.**18 (G) **“HEMP” HAS THE MEANING STATED IN § 14–101 OF THE AGRICULTURE**
19 **ARTICLE.**

20 [(f)] (H) “Indoor area open to the public” means:

21 (1) An indoor area or a portion of an indoor area accessible to the public by
22 either invitation or permission; or23 (2) An indoor area of any establishment licensed or permitted under the
24 Alcoholic Beverages and Cannabis Article for the sale or possession of alcoholic beverages.25 [(g)] (I) “Place of employment” has the meaning stated in § 5–101 of the Labor
26 and Employment Article.27 [(h)] (J) “Smoking” means the burning of a lighted cigarette, cigar, pipe, or any
28 other matter or substance containing, wholly or in part, tobacco, cannabis, or hemp.29 (K) **“TOBACCO PRODUCT” HAS THE MEANING STATED IN § 13–1001 OF THIS**

1 ARTICLE.

2 (L) "VAPING" MEANS THE USE OF:

3 (1) AN ELECTRONIC SMOKING DEVICE; OR

4 (2) ANY DEVICE THROUGH WHICH THE USER INHALES AEROSOL
5 CONTAINING HEMP OR CANNABIS.

6 24-504.

7 Except as provided in § 24-505 of this subtitle, beginning on February 1, 2008, a
8 person may not smoke OR VAPE in:

9 (1) An indoor area open to the public;

10 (2) An indoor place in which meetings are open to the public in accordance
11 with Title 3 of the General Provisions Article;

12 (3) A government-owned or government-operated means of mass
13 transportation including buses, vans, trains, taxicabs, and limousines; or

14 (4) An indoor place of employment.

15 24-505.

16 This subtitle does not apply to:

17 (1) Private homes, residences, including residences used as a business or
18 place of employment, unless being used by a person who is licensed or registered under
19 Title 5, Subtitle 5 of the Family Law Article to provide child care, and private vehicles,
20 unless being used for the public transportation of children, or as part of health care or child
21 care transportation;

22 (2) A hotel or motel room rented to one or more guests as long as the total
23 percent of hotel or motel rooms being so used does not exceed 25%;

24 (3) A retail tobacco business that is a sole proprietorship, limited liability
25 company, corporation, partnership, or other enterprise, in which:

26 (i) The primary activity is the retail sale of tobacco products and
27 accessories; and

28 (ii) The sale of other products is incidental;

29 (4) Any facility of a manufacturer, importer, wholesaler, or distributor of

1 tobacco products or of any tobacco leaf dealer or processor in which employees of the
2 manufacturer, importer, wholesaler, distributor, or processor work or congregate; or

3 (5) A research or educational laboratory for the purpose of conducting
4 scientific research into the health effects of [tobacco] ENVIRONMENTAL smoke.

5 24–506.

6 (a) Signs that state “Smoking OR VAPING Permitted in This Room” shall be
7 prominently posted and properly maintained where smoking OR VAPING is allowed under
8 § 24–505(2) of this subtitle.

9 (B) SIGNS THAT STATE “NO SMOKING OR VAPING” SHALL BE
10 CONSPICUOUSLY POSTED AND PROPERLY MAINTAINED IN EACH INDOOR AREA OPEN
11 TO THE PUBLIC AND EACH PUBLIC ENTRANCE TO AN INDOOR AREA WHERE SMOKING
12 OR VAPING IS PROHIBITED UNDER THIS SUBTITLE.

13 [(b)] (C) The signs shall be posted and maintained by the owner, operator,
14 manager, or other person having control of the area.

15 [(c)] (D) The letters on the signs shall be at least 1 inch in height.

17 (c) (2) It is an affirmative defense to a complaint brought against a person for
18 a violation of a provision of this subtitle or a regulation adopted under this subtitle that the
19 person or an employee of the person:

20 (i) Posted a “No [Smoking] SMOKING OR VAPING” sign as
21 required under § 24–506 of this subtitle;

22 (ii) Removed all ashtrays and other smoking OR VAPING
23 paraphernalia from all areas where smoking is prohibited; and

24 (iii) If the violation occurred in a bar, tavern, or restaurant:

25 1. Refused to seat or serve any individual who was smoking
26 OR VAPING in a prohibited area; and

27 2. If the individual continued to smoke OR VAPE after an
28 initial warning, asked the individual to leave the establishment.

30 (a) Within 90 days from the receipt of an application for a waiver and the date

1 that all conditions for the application for a waiver required in the regulations adopted by
2 the Secretary have been satisfied, the health officer of a county may grant a waiver from
3 the application of a specific provision of this subtitle, if prior to the granting of the waiver,
4 the applicant for a waiver establishes in writing:

5 (1) Compliance with a specific provision of this subtitle would cause undue
6 financial hardship; or

7 (2) The existence of other factors that would render compliance
8 unreasonable.

9 (b) The Secretary may impose conditions or restrictions on a waiver granted
10 under subsection (a) of this section to:

11 (1) Minimize the adverse effects of the waiver on individuals involuntarily
12 exposed to secondhand smoke; and

13 (2) Ensure that the waiver is consistent with the purposes of this subtitle.

14 (c) The Secretary shall adopt regulations necessary to implement this section.

15 (d) (1) A waiver may not be granted under subsection (a) of this section on or
16 after January 31, 2011.

17 (2) A waiver granted under subsection (a) of this section terminates on
18 January 31, 2011.]

19 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 24–510 and 24–511
20 of Article – Health – General of the Annotated Code of Maryland be renumbered to be
21 Section(s) 24–509 and 24–510, respectively.

22 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2024.
