1 AN ACT concerning

2 **Vehicle Laws – Motor Vehicle Insurance Companies – Requirements**

3 FOR the purpose of requiring motor vehicle insurance companies to participate in a certain
4 program of insurance verification for motor vehicle insurance policies; requiring
5 motor vehicle insurance companies to provide certain customer information details;
6 and generally relating to motor vehicle insurance.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Transportation**

2 (a) The Administration may not issue or transfer the registration of a motor
3 vehicle unless the owner or prospective owner of the vehicle furnishes evidence satisfactory
4 to the Administration that the required security is in effect.

5 (b) The owner of a motor vehicle that is required to be registered in this State
6 shall maintain the required security for the vehicle during the registration period.

7 (c) Each insurer or other provider of required security shall:

8 (1) [Except as provided in item (2) of this subsection, immediately notify
9 the Administration electronically of new motor vehicle insurance policies issued for insured
10 vehicles registered in the State; and] **PARTICIPATE IN THE ADMINISTRATION'S ONLINE
11 VERIFICATION PROGRAM FOR VEHICLE INSURANCE POLICIES FOR LAW
12 ENFORCEMENT AND ADMINISTRATIVE PURPOSES;**

13 (2) For each fleet policy, electronically notify the Administration every 30
14 days of any additions, deletions, or modifications to the fleet policy, including those policy
15 numbers affected; **AND**

16 **(3) ELECTRONICALLY PROVIDE THE ADMINISTRATION WITH ALL
17 ACTIVE INSURANCE POLICIES:**

18 **(I) IN A FORMAT REQUIRED BY THE ADMINISTRATION; AND**

19 **(II) AT AN INTERVAL DETERMINED BY THE ADMINISTRATION.**

20 (d) The Administration, in consultation with the Maryland Insurance
21 Administration and representatives of the automobile insurance industry, shall adopt
22 regulations that establish procedures to be used by an insurer to provide timely notification
23 to an insured of the penalties that may be imposed in accordance with § 17-106 of this
24 subtitle if the insured fails to renew or replace a policy of motor vehicle liability insurance
25 without surrendering the evidences of registration.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 ~~October 1, 2024~~ January 1, 2025.
