BY repealing and reenacting, without amendments, Article – Transportation Section 13–619.1(a)(1) Annotated Code of Maryland (2020 Replacement Volume and 2023 Supplement) BY repealing and reenacting, with amendments, Article – Transportation Section 13–619.1(a)(4), (b), and (c)(2)(iii) Annotated Code of Maryland (2020 Replacement Volume and 2023 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

The fee shall be calculated to: 25(2)26 (i) Recover the costs incurred by the Administration in carrying out 27 the provisions of this section; and Result in a surplus of at least \$10 for each issuance of new 28 (ii) registration plates under this section. 29
