11 12	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows:

15	(a) A person may not willfully and knowingly:
16 17	(1) (i) impersonate another person in order to vote or attempt to vote or
18	(ii) vote or attempt to vote under a false name;
19 20	(2) vote more than once for a candidate for the same office or for the same ballot question;
21 22	(3) vote or attempt to vote more than once in the same election, or vote in more than one election district or precinct;

15 16 17	(b) Except as provided in § 16–1002 of this title, a person who violates this section is guilty of a misdemeanor and on conviction is subject to a fine of not more than \$5,000 or imprisonment for not more than 5 years or both.

A person who violates this section is subject to § 5–106(b) of the Courts Article.
