BY repealing and reenacting, with amendments, Article – Natural Resources Section 10–404(e) Annotated Code of Maryland (2023 Replacement Volume and 2023 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Natural Resources 10-404. (1) Except as provided in [paragraph] PARAGRAPHS (2) AND (3) of this subsection or § 10-512(a)(2)(ii) of this title, a person may not sell, offer for sale, barter, or exchange, at any time within the State any game bird or game mammal taken from the wild, in the State or in another state, territory, or country. (2)The prohibitions of paragraph (1) of this subsection do not apply to the:
