- 3 FOR the purpose of altering the Law Enforcement Cadet Apprenticeship Program in the Maryland Department of Labor to be the Public Safety Apprenticeship Program; 4 5 expanding the purpose and scope of the Program to promote careers with certain 6 public safety agencies; increasing the maximum amount of a grant altering the 7 eligibility criteria and the types of grants that may be awarded under the Program; 8 requiring the Maryland Police Training and Standards Commission to develop 9 certain mental health wellness policies to be implemented in certain law 10 enforcement agencies and correctional facilities; establishing the Workgroup on Growing Engagement in the Law Enforcement and the Corrections Workforce to 11 12 study and make recommendations on increasing law enforcement employment in the 13 State; and generally relating to the Public Safety Apprenticeship Program, the duties of the Maryland Police Training and Standards Commission, and the 14 15 Workgroup on Growing Engagement in the Law Enforcement and the Corrections 16 Workforce.
