- 10 (V) LEOPARD, EXCLUDING CLOUDED LEOPARD;

- 12 (VII) NONHUMAN PRIMATE; OR

- 4 (A) THIS SECTION DOES NOT APPLY TO A PERFORMANCE THAT TAKES

- 14 (1) A STATE OR LOCAL LAW ENFORCEMENT OFFICER;
- 15 (2) AN OFFICER OR AGENT OF THE DEPARTMENT; OR
- 16 (3) THE LOCAL ANIMAL CONTROL AUTHORITY FOR THE
- 17 JURISDICTION WHERE THE VIOLATION OCCURS.

- 19 (b) Any person who violates any provision of this title is guilty of a misdemeanor.
- 20 Unless another penalty is specifically provided elsewhere in this title, the person, upon
- 21 conviction, is subject to a fine not exceeding \$1,500, with costs imposed in the discretion of
- 22 the court.
- 23 (e) This section does not apply to a violation of § 10–2C–02 OR § 10–424(2) of
- 24 this title.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not be construed
- 26 to preempt or prevail over any ordinance, resolution, law, or rule more stringent than this
- 27 Act.
- 28 SECTION 3. AND BE IT FURTHER ENACTED, That, if any provision of this Act or
- 29 the application thereof to any person or circumstance is held invalid for any reason in a
- 30 court of competent jurisdiction, the invalidity does not affect other provisions or any other
- 31 application of this Act that can be given effect without the invalid provision or application,
- 32 and for this purpose the provisions of this Act are declared severable.

SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
