1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 2 That the Laws of Maryland read as follows: 3 Article - Natural Resources SUBTITLE 2C. - 1 (E) "TRAVELING ANIMAL ACT" MEANS ANY PERFORMANCE OF ANIMALS FOR
- 2 WHICH THE ANIMALS ARE TRANSPORTED IN A MOBILE OR TRAVELING HOUSING
- 3 FACILITY TO, FROM, OR BETWEEN LOCATIONS FOR THE PURPOSE OF THE

- 6 (A) THIS SECTION DOES NOT APPLY TO A:
- 7 (1) A PERFORMANCE THAT TAKES PLACE AT A NONMOBILE,
- 8 PERMANENT INSTITUTION OR OTHER FIXED FACILITY, PROVIDED THAT THE
- 9 COVERED ANIMAL IS NOT TRANSPORTED TO THE INSTITUTION OR FACILITY FOR THE

- 11 (2) THE TRANSPORT OF A CLOUDED LEOPARD TO A LOCATION FOR

- 14 (B) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, A PERSON MAY

- 17 (C) A PERSON WHO VIOLATES THIS SECTION IS SUBJECT TO A CIVIL
- 18 PENALTY NOT TO EXCEED \$2,000 PER VIOLATION.
- 19 (D) THE PROVISIONS OF THIS SECTION MAY BE ENFORCED BY:
- 20 (1) A STATE OR LOCAL LAW ENFORCEMENT OFFICER; OR
- 21 (2) AN OFFICER OR AGENT OF THE DEPARTMENT; OR
- 22 (3) THE LOCAL ANIMAL CONTROL AUTHORITY FOR THE
- 23 JURISDICTION WHERE THE VIOLATION OCCURS.

- 25 (b) Any person who violates any provision of this title is guilty of a misdemeanor.
- 26 Unless another penalty is specifically provided elsewhere in this title, the person, upon
- 27 conviction, is subject to a fine not exceeding \$1,500, with costs imposed in the discretion of
- 28 the court.
- 29 (e) This section does not apply to a violation of $\S 10-2C-02$ OR $\S 10-424(2)$ of
- 30 this title.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act may not be construted to preempt or prevail over any ordinance, resolution, law, or rule more stringent than the Act.
SECTION 3. AND BE IT FURTHER ENACTED, That, if any provision of this Act the application thereof to any person or circumstance is held invalid for any reason in court of competent jurisdiction, the invalidity does not affect other provisions or any oth application of this Act that can be given effect without the invalid provision or application and for this purpose the provisions of this Act are declared severable.
SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effection 1, 2024 .
