13	(a) (1) In this section the following words have the meanings indicated.
14 15 16	(4) "Individualized education program" and "individualized family service plan" have the same meaning as provided in the federal Individuals with Disabilities Education Act.
17 18 19	(b) (1) When a team of qualified professionals and the parents meet for the purpose of discussing the identification, evaluation, educational program, or the provision of a free appropriate public education of a child with a disability:
20 21	(i) The parents of the child shall be afforded the opportunity to participate and shall be provided reasonable notice in advance of the meeting; and
22 23	(ii) Reasonable notice shall be at least 10 calendar days in advance of the meeting, unless an expedited meeting is being conducted to:
24	1. Address disciplinary issues;
25 26	2. Determine the placement of the child with a disability not currently receiving educational services; or
27 28	3. Meet other urgent needs of a child with a disability to ensure the provision of a free appropriate public education.
29 30	(2) (i) 1. At the initial evaluation meeting, the parents of the child shall be provided:
31 32 33	A. In plain language, an oral and written explanation of the parents' rights and responsibilities in the individualized education program process and a program procedural safeguards notice;

- B. Written information that the parents may use to contact early intervention and special education family support services staff members within the local school system and a brief description of the services provided by the staff members; [and]
- C. Written information on the Special Education Ombudsman and toll–free telephone number established under Title 6, Subtitle 5 of the State Government Article; AND
- B. WRITTEN INFORMATIONAL MATERIALS REGARDING
  THE MARYLAND ABLE PROGRAM PROVIDED UNDER § 18–19C–03(A)(2) OF THIS
  ARTICLE.
- 11 2. АТ LEAST ONE TIME **EACH YEAR**  $\mathbf{AT}$ AN INDIVIDUALIZED EDUCATION PROGRAM OR INDIVIDUALIZED FAMILY SERVICE PLAN 12 TEAM MEETING, THE PARENTS OF THE CHILD SHALL BE PROVIDED WITH THE 13 14 WRITTEN INFORMATIONAL MATERIALS DESCRIBED UNDER SUBSUBPARAGRAPH 1D OF THIS SUBPARAGRAPH. 15

- (iv) A local school system shall publish information that a parent may use to contact early intervention and special education family support services staff members within the local school system and a brief description of the services provided by the staff members in a prominent place on the section of its website relating to special education services.
