CHAPTER
AN ACT concerning
Human Services – Individuals With Disabilities and Service–Disabled Veterans Boating Fund
FOR the purpose of establishing the Individuals With Disabilities and Service–Disabled Veterans Boating Fund; requiring the Department of Disabilities to administer the Fund; establishing the qualifications for certain organizations to receive grants from the Fund; authorizing the Governor to include in the annual budget bill a certain appropriation—for—the—Fund; and generally relating to the Individuals With Disabilities and Service–Disabled Veterans Boating Fund.
BY adding to Article – Human Services Section 7–1101 and 7–1102 to be under the new subtitle "Subtitle 11. Individuals With Disabilities and Service–Disabled Veterans Boating Fund"

CHESAPEAKE BAY OR ITS TRIBUTARIES STATE WATERS AT LEAST 25 TIMES IN EACH OF THE PAST 3 YEARS.
