3 FOR the purpose of requiring the Comptroller, beginning in a certain fiscal year, to distribute a certain amount of abandoned property funds to the Tax Clinics for 4 5 Low-Income Marylanders Fund; requiring the Governor to include a certain amount 6 of funding in the annual budget for the CASH Campaign of Maryland to award 7 grants for providing certain tax assistance through certain on-demand and mobile 8 tax clinics; requiring certain grant recipients to interact with the CASH Campaign 9 in a certain manner for a certain purpose; and generally relating to tax assistance for low-income Marylanders. 10
