A BILL ENTITLED

1 AN ACT concerning

2 **State Officers and Employees – Required Surety Bonds – Insurance Policies**
3 **Authorized**

4 FOR the purpose of altering the requirements that certain officers and employees of the
5 State be covered by certain surety bonds to allow the officers and employees to be
6 covered by certain insurance policies; transferring certain duties and responsibilities
7 of the Maryland State Employees Surety Bond Committee to the State Treasurer;
8 repealing certain provisions of law related to the approval, form, and record of
9 certain surety bonds required for certain officers and employees of the State; and
10 generally relating to surety bond and insurance coverage requirements for certain
11 officers and employees of the State.

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
28 That the Laws of Maryland read as follows:

32 (8) Provide for the execution of surety bonds **OR INSURANCE POLICIES**
33 **OF THE TYPE AND IN THE AMOUNT OF COVERAGE DETERMINED BY THE STATE**

35 employee or officer entrusted with funds or property;

1 (c) The supervisors shall provide for the execution of surety bonds **OR**
2 **INSURANCE POLICIES OF THE TYPE AND IN THE AMOUNT OF COVERAGE**
3 **DETERMINED BY THE STATE TREASURER UNDER § 5-108 OF THE STATE**
4 **GOVERNMENT ARTICLE** for every employee and officer who is entrusted with funds or
5 property. They shall provide for the keeping of a full and accurate record of all proceedings
6 and of all resolutions, rules and regulations, and orders issued or adopted. They shall

7 section shall be paid by the Division.

8 (d) An individual who fails to provide or maintain a surety bond **OR AN**
9 **INSURANCE POLICY** as required by this section:

10 (1) may not assume the duties of the individual's position; and

11 (2) after 30 days, forfeits the individual's office or employment.

11 (a) While in office, the Treasurer shall be covered by a surety bond **OR AN**

14 (1) run to the State;

15 (2) be in the amount that the Governor approves;

16 (3) be with a surety company that is authorized to do business in the State;

18 (4) include provisions that secure the money of:

19 (i) the Injured Workers' Insurance Fund;

20 (ii) the Subsequent Injury Fund; and

21 (iii) the Unemployment Insurance Administration Fund.

22 (c) (1) If the Governor believes that **[the] A** surety bond under this section has
23 or is likely to become invalid or insufficient, the Governor shall demand that the Treasurer
24 obtain coverage under a new surety bond that meets the requirements of this section.

25 (2) Neglect or refusal to obtain the coverage within 20 days after the
26 demand constitutes disqualification from office, as authorized in the Maryland
27 Constitution.

28 (d) After execution and approval of a surety bond under this section, the surety
29 bond shall be recorded in the office of the Clerk of the Supreme Court of Maryland.

1 **(E) (1) THE GOVERNOR, IN CONSULTATION WITH THE STATE**
2 **TREASURER, SHALL DETERMINE THE TYPE AND AMOUNT OF COVERAGE PROVIDED**
3 **BY AN INSURANCE POLICY PURCHASED UNDER SUBSECTION (A) OF THIS SECTION.**

4 **(2) THE STATE TREASURER SHALL KEEP A RECORD OF ANY**
5 **INSURANCE POLICY PROCURED FOR THE PURPOSE OF MEETING THE**
6 **REQUIREMENTS OF SUBSECTION (A) OF THIS SECTION.**

8 (a) In addition to the bond **OR INSURANCE POLICY** required under § 5–102 of
9 this subtitle, the State Treasurer shall be covered by a surety bond [as required in] **OR AN**
10 **INSURANCE POLICY MEETING THE REQUIREMENTS OF** this section.

11 (b) [The] **A** surety bond [under] **PURCHASED TO MEET THE REQUIREMENTS**
12 **OF SUBSECTION (A) OF** this section shall:

13 (1) be conditioned on the faithful performance of the duties of the State

26 **5–108 OF THIS SUBTITLE.**

28 **(A) IN DETERMINING THE TYPE AND AMOUNT OF COVERAGE OF ANY SURETY**
29 **BOND OR INSURANCE POLICY REQUIRED BY LAW, THE STATE TREASURER SHALL**
30 **HAVE DUE REGARD FOR THE DUTIES AND RESPONSIBILITIES OF THE OFFICER OR**
31 **EMPLOYEE.**

1 **(B) AN OFFICER OR EMPLOYEE WHO IS REQUIRED TO BE BONDED OR**
2 **INSURED SHALL BE COVERED, ON BEGINNING THE PERFORMANCE OF THE**
3 **OFFICER’S OR EMPLOYEE’S DUTIES, BY A SURETY BOND OR AN INSURANCE POLICY**
4 **OF THE TYPE SPECIFIED AND IN THE AMOUNT AND TERM TO BE DETERMINED BY THE**
5 **STATE TREASURER.**

6 **(C) EACH STATE OFFICER OR EMPLOYEE, OTHER THAN THOSE**
7 **SPECIFICALLY REQUIRED TO BE BONDED OR INSURED IN ACCORDANCE WITH ANY**
8 **LAW OF THE STATE, WHO IN THE OPINION OF THE STATE TREASURER SHOULD BE**
9 **BONDED OR INSURED SHALL BE BONDED WITH THE TYPE OF BOND OR INSURANCE**
10 **AND IN THE AMOUNT AND TERM TO BE DETERMINED BY THE STATE TREASURER.**

11 **(D) THE STATE TREASURER SHALL KEEP A RECORD OF EACH INSURANCE**
12 **POLICY PURCHASED TO MEET THE REQUIREMENTS OF SUBSECTION (B) OF THIS**
13 **SECTION.**

14 **(E) (1) ON THE PURCHASE OF ANY BOND REQUIRED BY LAW, A COPY OF**
15 **THE BOND SHALL BE SENT TO THE COMPTROLLER.**

16 **(2) A RECORD SHALL BE KEPT IN THE OFFICE OF THE STATE**
17 **COMPTROLLER GIVING:**

18 **(I) THE NAME OF THE OFFICER OR EMPLOYEE FOR WHOM ANY**
19 **INDIVIDUAL BOND IS ISSUED;**

20 **(II) THE NAME OF THE AGENCY IN WHICH THE OFFICER OR**
21 **EMPLOYEE IS EMPLOYED OR THE NAME OF THE AGENCIES COVERED UNDER A**
22 **BLANKET BOND PROGRAM;**

23 **(III) THE NAME OF THE COMPANY ISSUING THE BOND; AND**

24 **(IV) THE AMOUNT, DATE, AND TIME OF EXPIRATION OF THE**
25 **BOND AND OF ANY CERTIFICATE RENEWING THE BOND.**

26 **[Subtitle 17. Maryland State Employees Surety Bond Committee.]**

27 **[9–1701.**

28 In this subtitle, “Committee” means the Maryland State Employees Surety Bond
29 **Committee.]**

30 **[9–1702.**

1 There is a committee on bonding of State officers and employees, known as the
2 Maryland State Employees Surety Bond Committee.]

3 [9-1703.

4 The Committee consists of the State Treasurer, the State Comptroller, and the
5 Attorney General or their designated representatives.]

6 [9-1704.

7 (a) The Committee may periodically set the type and amount of the bonds of each
8 State officer and employee who is required to be bonded in accordance with any law of the
9 State, having due regard for the duties and responsibilities of the officer or employee.

10 (b) An officer or employee who is required to be bonded shall be covered, on
11 entering the performance of the officer's or employee's duties, by a surety bond of the type
12 specified and in the amount and term fixed by the Committee.]

13 [9-1705.

14 Each State officer or employee other than those specifically required to be bonded in
15 accordance with any law of the State, who in the opinion of the Committee should be
16 bonded, shall be bonded with the type of bond and in the amount and term to be determined
17 by the Committee.]

18 [9-1706.

19 (a) Bonds purchased in accordance with §§ 9-1704 and 9-1705 of this subtitle
20 shall be purchased by the State Treasurer on prior approval of the Board of Public Works
21 from a company authorized to issue the bonds and authorized to do business in the State.

22 (b) The premium on bonds purchased in accordance with §§ 9-1704 and 9-1705
23 of this subtitle shall be provided for in the State budget.

24 (c) On prior approval of the Board of Public Works, the State Treasurer may at
25 any time any bond coverage is no longer required, cause the bond to be canceled or
26 terminated and may collect any rebate of premium on the bond.]

27 [9-1707.

28 (a) Each bond required by §§ 9-1704 and 9-1705 of this subtitle shall be approved
29 as to form by the Attorney General and filed in the Office of the State Comptroller.

30 (b) A record shall be kept in the Office of the State Comptroller giving:

1 (1) the name of the officer or employee for whom any individual bond is
2 issued;

3 (2) the name of the agency in which the officer or employee is employed or
4 the name of the agencies covered under a blanket bond program;

5 (3) the name of the company issuing the bond; and

6 (4) the amount, date, and time of expiration of the bond and of any
7 certificate renewing the bond.]

10 (a) Except as provided in subsection (c) of this section, the State shall purchase a
11 bond for each fiduciary in [accordance with Title 9, Subtitle 17 of the State Government
