- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 1 2 That the Laws of Maryland read as follows: 3 Article - Economic Development 4 13–1201. In this subtitle the following words have the meanings indicated. 5 (a) 6 ["Additive manufacturing" means a process of joining materials to make objects from three-dimensional model data, usually layer upon layer, as opposed to 7 8 subtractive manufacturing methodologies. 9 "Board" means the Executive Board of the Partnership.
