# Economic Development - Regional Additive Manufacturing Partnership of Maryland - Alterations

FOR the purpose of renaming the Regional Additive Manufacturing Partnership of Maryland to be the Regional Advanced Manufacturing Partnership of Maryland; altering the purposes and duties of the Partnership and composition of the Executive Board of the Partnership; renaming the Regional Additive Manufacturing Partnership of Maryland Fund to be the Regional Advanced Manufacturing Partnership of Maryland Fund; and generally relating to the Regional Additive Manufacturing Partnership of Maryland and advanced manufacturing.

3 (a) (2) (i) Notwithstanding any other provision of law, and unless 4 inconsistent with a federal law, grant agreement, or other federal requirement or with the 5 terms of a gift or settlement agreement, net interest on all State money allocated by the 6 State Treasurer under this section to special funds or accounts, and otherwise entitled to 7 receive interest earnings, as accounted for by the Comptroller, shall accrue to the General 8 Fund of the State.

9 (ii) The provisions of subparagraph (i) of this paragraph do not apply 10 to the following funds:
