- 1 (a) To the extent included in federal adjusted gross income, the amounts under 2 this section are subtracted from the federal adjusted gross income of a resident to determine 3 Maryland adjusted gross income.
- 4 (e-1) (1) In this subsection, "law enforcement officer" means a law enforcement officer as defined in § 1-101 of the Public Safety Article or other sworn law enforcement officer of the United States, a state, or a political subdivision of a state.
 - (2) The subtraction under subsection (a) of this section includes:
- 8 (I) a payment from a pension system to the surviving spouse or other 9 beneficiary of a law enforcement officer or fire fighter whose death arises out of or in the 10 course of employment as a law enforcement officer or fire fighter; AND
- 11 (II) A PAYMENT OF A DEATH BENEFIT UNDER A COLLECTIVE
 12 BARGAINING AGREEMENT FROM A COUNTY OR MUNICIPALITY IN THE STATE TO THE
 13 SURVIVING SPOUSE OR OTHER BENEFICIARY OF A LAW ENFORCEMENT OFFICER OR
 14 FIRE FIGHTER WHOSE DEATH ARISES OUT OF OR IN THE COURSE OF EMPLOYMENT

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024, and shall be applicable to all taxable years beginning after December 31, 2021.
