A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – Class B Beer, Wine, and Liquor Licenses**

3 FOR the purpose of authorizing the Board of License Commissioners for Baltimore City to
4 issue a Class B beer, wine, and liquor license in a certain area; establishing the
5 requirements for a holder of the license; and generally relating to alcoholic beverages
6 licenses in Baltimore City.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages and Cannabis**

20 12–102.

21 This title applies only in Baltimore City.

22 **12–1606.**

1 **(A) NOTWITHSTANDING ANY OTHER PROVISION OF LAW IN THIS TITLE, THE**
2 **BOARD MAY ISSUE A CLASS B BEER, WINE, AND LIQUOR LICENSE FOR USE BY A**
3 **RESTAURANT IN WARD 4, PRECINCTS 1 AND 2 THAT:**

4 **(1) HAS AVERAGE DAILY RECEIPTS FROM THE SALE OF FOOD THAT**
5 **ARE AT LEAST 51% OF THE TOTAL DAILY RECEIPTS OF THE RESTAURANT;**

6 **(2) HAS BEEN CLASSIFIED BY THE BALTIMORE CITY HEALTH**
7 **DEPARTMENT AS:**

8 **(I) A HIGH PRIORITY FOOD SERVICE FACILITY; OR**

9 **(II) A MODERATE PRIORITY FOOD SERVICE FACILITY; AND**

10 **(3) HAS EXECUTED A MEMORANDUM OF UNDERSTANDING WITH THE**
11 **DOWNTOWN PARTNERSHIP OF BALTIMORE.**

12 **(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,**
13 **THE HOLDER OF A LICENSE ISSUED UNDER THIS SECTION MAY NOT SELL ALCOHOLIC**
14 **BEVERAGES FOR OFF-PREMISES CONSUMPTION.**

15 **(2) THE BOARD MAY ISSUE THE HOLDER OF A LICENSE ISSUED**
16 **UNDER THIS SECTION A REFILLABLE CONTAINER PERMIT IN ACCORDANCE WITH §**
17 **12-1102 OF THIS TITLE.**

18 **(C) A LICENSE ISSUED UNDER THIS SECTION MAY NOT BE TRANSFERRED**
19 **FROM THE LOCATION OF ITS FIRST ISSUANCE.**

20 **(D) IF A LICENSE ISSUED UNDER THIS SECTION IS RENEWED, THE LICENSE**
21 **HOLDER SHALL FILE WITH THE BOARD AS PART OF ITS RENEWAL APPLICATION:**

22 **(1) A STATEMENT DETAILING THE AVERAGE DAILY RECEIPTS FROM**
23 **THE RESTAURANT;**

24 **(2) AN AFFIDAVIT FROM A CERTIFIED PUBLIC ACCOUNTANT THAT**
25 **VERIFIES THAT THE LICENSE HOLDER MEETS THE REQUIREMENTS OF SUBSECTION**
26 **(B)(1) OF THIS SECTION; AND**

27 **(3) ANY OTHER INFORMATION THAT THE BOARD REQUIRES.**

28 **(E) THE BOARD:**

29 **(1) MAY NOT ISSUE A NEW LICENSE UNDER THIS SECTION AFTER**

1 **JUNE 30, 2028; BUT**

2 **(2) MAY CONTINUE TO RENEW LICENSES ISSUED ON OR BEFORE JUNE**
3 **30, 2028.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
5 1, 2024.
