10 (g) On or before December 1, 2025, the Workgroup shall report its findings and 11 recommendations to the Howard County Executive, the Howard County Council, the 12 Howard County Board of Education, and, in accordance with § 2–1257 of the State 13 Government Article, the members of the Howard County Delegation to the General 14 Assembly.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 16 1, 2024. It shall remain effective for a period of 1 year and 7 months and, at the end of 17 December 31, 2025, this Act, with no further action required by the General Assembly, shall 18 be abrogated and of no further force and effect.
